

BEFORE THE ARKANSAS STATE MEDICAL BOARD
IN THE MATTER OF: TODD MICHAEL CLEMENTS

CONSENT ORDER

On this day comes on for hearing the matter of Todd Michael Clements, M.D. The Arkansas State Board appeared together by a quorum of its membership together with its attorney, Kevin M. O'Dwyer. Todd Michael Clements, M.D. appeared by and through his attorney Charles M. Mooney, Jr. From the pleadings, evidence introduced, and agreement of the parties, the Board finds that:

I.

Todd Michael Clements, M.D., is a licensed physician in the State of Arkansas under the provisions of the Medical Practices Act.

II.

Todd Michael Clements, M.D. has been found guilty of committing three felonies, that is, obtaining Schedule medication by fraud for self-use in the State of Texas

III.

Todd Michael Clements, M.D., has surrendered his license to practice medicine in the State of Texas.

IV.

Pursuant to Ark. Code Ann. §17-95-307 the license to practice medicine in the State of Arkansas of Todd Michael Clements, M.D., is revoked in that he has admitted to a felony conviction, as well as the evidence entered into the record showing a felony conviction.

Todd Michael Clements, M.D., requested that a wavier be granted pursuant to Ark. Code Ann. §17-95-308. The Board heard testimony and took evidence and after a hearing granted the waiver, and,

therefore, his license to practice medicine in the State of Arkansas is reinstated forthwith and the suspension is lifted.

V.

Pursuant to Ark. Code Ann. §25-15-208(b) of the Administrative Procedure Act, Todd Michael Clements, M.D., makes the following offer to the Arkansas State Medical Board:

1. Todd Michael Clements, M.D., agrees to pay the costs of the investigation of \$297.75 within 30 days of the date of this Order. If he fails to do so it will be considered a violation of this Order.
2. Todd Michael Clements, M.D., has signed a contract with the Arkansas Medical Foundation and agrees to follow all the recommendations of the Foundation and stay compliant with that contract and shall maintain the advocacy of the Foundation.
3. The Contract will include but is not limited to an annual polygraph test, random drug screens, continued therapy and Dr. Clements' continued participation in a recovery program.
4. Todd Michael Clements, M.D., has already attended a Boundaries Course.
5. Todd Michael Clements, M.D., will return in August 2014 to the Board, and at all times as the Board deems necessary.
6. When Dr. Clements obtains employment he must appear before the Board with his new employer.

VI.

Pursuant to the Ark. Code Ann. §25-15-208(b) of the Administrative Procedure Act the Arkansas State Medical Board accepts the offer of Todd Michael Clements, M.D.

WHEREFORE, IT IS CONSIDERED, ORDERED AND ADJUED that the agreement of the parties stated in Paragraphs IV and V above is a fair and an equitable agreement; protects the health and safety of the citizens of Arkansas, and the rights of Todd Michael Clements, M.D. The Board adopts the terms of said Agreement as the Board's own Order.

IT IS SO ORDERED.


