ORDER OF SUSPENSION PURSUANT TO SECTION 12-240-125(5)(c)(IV), C.R.S.

IN THE MATTER OF THE LICENSE TO PRACTICE MEDICINE AS A PHYSICIAN IN THE STATE OF COLORADO OF KHAJA NAJIBUDDI CHISTY, M.D., LICENSE NUMBER DR.0051265,

TO: KHAJA NAJIBUDDIN CHISTY, M.D.:

THIS MATTER was reviewed by Inquiry Panel B ("Panel") of the Colorado Medical Board ("Board") during a regularly scheduled meeting of the Panel on February 18, 2022. The Panel finds that after reviewing all available information in relation to the above-captioned case:

- 1. Respondent was licensed to practice medicine in the state of Colorado on May 16, 2012 and was issued license number DR.0051265 to practice medicine in the state of Colorado.
- 2. On or about April 26, 2018, the Panel and Respondent entered into a Stipulation and Final Agency Order in lieu of a formal disciplinary hearing. The terms and conditions of the Order were imposed pursuant to the authority of Section 12-240-125(5)(c)(III), V.R.S. As provided in paragraph 63, the Order and its terms constitute a valid board order for the purposes of Section 12-240-121(1)(n), C.R.S. Respondent agreed to be bound by the terms and conditions as set forth in the Order.
- 3. By the terms of the Order, Respondent was required to refrain from using telehealth technologies to practice medicine for the duration of the five-year probationary period.
- 4. On or about February 18, 2022, the Panel reviewed all matters set forth in case number 2021-6801-B. Specifically, the Panel reviewed information that you treated a patient via telehealth technologies beginning in June 2021.
- 5. The Panel finds that Respondent has violated paragraph 15 of the Order, which required Respondent to refrain from using telehealth technologies to practice medicine.
- 6. Pursuant to Section 12-240-125(5)(c)(IV), C.R.S., the Panel is authorized to suspend Respondent's license to practice medicine in the State of Colorado until the licensee complies with all conditions of the Order.

THEREFORE IT IS ORDERED THAT:

- A. Respondent's license to practice medicine in this state is hereby suspended in accordance with Section 12-240-125(5)(c)(IV), C.R.S., effective at 5:00 p.m., February 24, 2022; and
- B. The suspension shall remain in effect until such time as Respondent is in full compliance with his Stipulation and Final Agency Order, the Panel has evaluated the evidence confirming compliance, and this Order of Suspension is vacated.
