Shredded 'ballot' an 'isolated incident'

Mequon officials respond to Belling statements

Mequon — City officials say a claim by a Milwaukee radio talk show host of "a shredded ballot" in Mequon in the April 5 election was "an unusual set of circumstances and an isolated incident."

Mark Belling, who has an afternoon radio program on WISN and whose column appears in the News Graphic, filed an open records request with

the city of Mequon the day after the election, "demanding any ballot submitted but not cast in yesterday's election, including any remnant of a shredded ballot."

A statement posted on Belling's Web site went on to say: "We have received reports Mequon poll workers destroyed submitted ballots before poll closing time, demanding a driver's license number from the absentee voter."

Belling added, "I will consider seeking an injunction to back up my request if Mequon officials are not cooperative (sic)."

Mequon Mayor Curt Gielow said, "We believe it is important to get the facts out to the public to maintain the integrity of the election process in Mequon." The mayor added, "I believe the city went out of its way to do the right thing."

Gielow also said that he contacted Ozaukee County District Attorney Adam Gerol and invited him to investigate the incident for potential illegal activity. Gerol said Monday that he has talked to the city attorney and Mequon police.

"We are fortunate that we see very few election complaints in Ozaukee County," the district attorney said. "That said, the first step in any complaint is always to investigate the matter. Once all the witnesses have

Mequon child psychiatrist arrested in alleged abduction attempt

Incident reported on Florida beach

Mequon — A 47-year-old child psychiatrist from Mequon has been arrested in Florida for allegedly trying to take children away from their parents at a beach, according to the Web site for a Fort Myers, Fla., newspaper.

Kimberly Hammes Frank was arrested by deputies from the Collier County Sheriff's Department shortly before 6 p.m. Wednesday. The arrest report says several deputies responded to Clam Pass Beach to investigate a "possible child abduction attempt" that was phoned in to 911.

The caller told deputies he was sitting on the beach when he heard his wife yell for help "while she was in

the Gulf with their three children." The caller said he looked up to see a white female with her hands on his 4-year-old son and his 9-year-old daughter. "His 8-year-old son was running toward him screaming for help also," the report said.

The man said he ran to the water and his wife told him that "this lady (Kim) would not release their two children from her grasp while in 2 1/2 feet of water." He added that he "had to pry the fingers of Kim loose to free his son and daughter, who suffered scratches to their arms and neck/shoulder, due to the actions of Kim Frank," said the sheriff's department report, which had the names of the children and their parents redacted.

The mother said, "Kim Frank approached her kids in the water and grabbed them by their arms while screaming, 'These are my kids, Mattie and Meredith,'" the report said.

The report added that Frank

was transported "without incident" and refused to be interviewed by investigators.

An online physician profile of Frank from a health care provider where she no longer works said her areas of interest were adolescent and child psychiatry. She received her medical degree from the Medical College of Wisconsin and served a residency and fellowship at Creighton University in Omaha, Neb. The Web site says she is board certified in psychiatry and child and adolescent psychiatry.

The News Graphic learned that Frank recently has practiced for at least two health facilities in the Milwaukee area. Here are statements provided by their public relations offices:

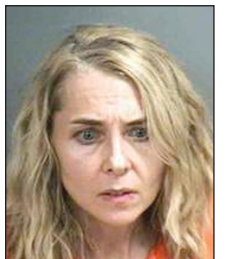
■ "Dr. Frank is a part-time employee at Aurora in Glendale," said Myrle Croasdale, public affairs manager for Aurora Health Care. "In response to the charges, she has been

placed on suspension pending an investigation. Aurora Health Care will cooperate fully with authorities as they investigate this case.

■ "Kimberly Frank, MD, was a sub-contracted psychiatrist with Froedtert Health Medical Group," said Carolyn Bellin, chief public relations officer for Froedtert and the Medical College of Wisconsin. "Dr. Frank has not been seeing patients at the Froedtert Health Behavioral Health Center in Menomonee Falls for the past several weeks and is no longer contracted to provide these services for Froedtert Health Medical Group."

Frank is currently in custody in the Collier County Jail, according to news-press.com of Fort Myers, Fla.
