[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

A DESKTOP COMPUTER TOWER WAS DISCOVERED MISSING FROM THE SPRINGHILL HEALTH CENTER (8491 NW 39 AVENUE) ON 3/09/10. THE STOLEN COMPUTER, WHICH WAS ORIGINALLY LOCATED IN A ROOM ADJACENT TO THE SUSPECT'S OFFICE, WAS REPLACED WITH AN OLDER COMPUTER. THE COMPUTER, WHICH WAS VALUED AT APPROXIMATELY \$800.00, POTENTIALLY CONTAINED SENSITIVE PATIENT INFORMATION. THE SUSPECT WAS TERMINATED ON OR ABOUT 2/26/10 FOR REASONS NOT RELATED TO THIS INCIDENT. I SPOKE TO JOHN GLASHEEN, A UNIVERSITY OF FLORIDA EMPLOYEE AND ACQUAINTANCE OF THE SUSPECT, WHO ADVISED THAT HE CONTACTED THE SUSPECT AND RODE WITH THE SUSPECT TO RETRIEVE THE COMPUTER, WHICH WAS AT THE SUSPECT'S PARENTS' HOUSE. GLASHEEN RETURNED THE COMPUTER TO THE INCIDENT LOCATION. DUE TO THE SUSPECT TEMPORARILY DEPRIVING THE UNIVERSITY OF FLORIDA OF ACCESS TO THEIR PROPERTY, I FILED A SWORN COMPLAINT ON THE SUSPECT FOR GRAND THEFT.
