ORDER OF EMERGENCY SUSPENSION OF LICENSE

Joseph A. Ladapo, MD, PhD, State Surgeon General, ORDERS the emergency suspension of the license of Steven B. Friedenthal, M.D., (Dr. Friedenthal) to practice medicine in the State of Florida. Dr. Friedenthal holds license number ME 56709. Dr. Friedenthal's address of record is 1071 Guildford Drive, Boca Raton, Florida 33434. The following Findings of Fact and Conclusions of Law support the emergency suspension of Dr. Friedenthal's license to practice medicine in the State of Florida.

FINDINGS OF FACT

1. The Department of Health (Department) is the state agency charged with regulating the practice of medicine pursuant to chapters 20, 456, and 458, Florida Statutes (2024). Section 456.073(8), Florida Statutes (2024), authorizes the State Surgeon General to summarily suspend Dr. Friedenthal's license to practice medicine in the State of Florida, in accordance with sections 120.60(6) and 456.074, Florida Statutes (2024).

2. At all times material to this Order, Dr. Friedenthal was licensed as a medical doctor in the State of Florida, pursuant to chapter 458.

- 3. The Palm Beach County Sheriff's Office (PBCSO) received three Cybertips from the National Center of Missing and Exploited Children concerning a Google user who used his Google drive account to upload several hundred files depicting the sexual abuse of children.
 - 4. All three Cybertips contained the same telephone number.
- 5. Pursuant to search warrant, both AT&T and Comcast verified that the subscriber for that telephone number was Dr. Friedenthal at 1071 Guildford Drive, Boca Raton, Florida 33434, and the telephone number on the Comcast account matched the AT&T telephone number on the reported Google account.
- 6. Pursuant to search warrant, Google provided over a terabyte of data content from the reported Google account.
- 7. PBCSO reviewed the content produced by Google and found thousands of Child Sexual Abuse Material (CSAM) image and video files.
- 8. On or about May 29, 2024, Dr. Friedenthal was arrested for possession of 10 or more files of child pornography, in violation of section 775.0847(2), Florida Statutes (2023)¹.

¹ Section 775.0847(2)(a) reclassifies a violation of section 827.071 from a third-degree felony to a second-degree felony when the defendant possesses 10 or more files.

9. On June 17, 2024, Dr. Friedenthal was charged² with 30 counts of

violating sections 827.071(5)(a) and 775.0847(2), Florida Statutes (2023).

10. Physicians are entrusted by the public to provide treatment to

patients in a manner that is safe, to act in the best interest of their patients,

and to protect their patients from harm. Accordingly, physicians are required

to demonstrate good judgment and moral character.

11. Dr. Friedenthal's possession of CSAM indicates that Dr. Friedenthal

lacks the good judgment and moral character necessary to be a physician.

Therefore, Dr. Friedenthal's continued practice as a physician presents a risk

of immediate, serious danger to the health, welfare, and safety of the public.

CONCLUSIONS OF LAW

Based on the foregoing findings of fact, the State Surgeon General

concludes as follows:

1. The State Surgeon General has jurisdiction over this matter

pursuant to section 20.43, Florida Statutes (2024), and chapters 456 and 458

as set forth above.

2. Section 456.072(1)(ss), Florida Statutes (2023), authorizes

discipline, including suspension, for being convicted or found guilty of; entering

a plea of guilty or nolo contendere to, regardless of adjudication; or committing

or attempting, soliciting, or conspiring to commit an act that would constitute

a violation of any of the offenses listed in section 456.074(5) or a similar

offense in another jurisdiction.

3. Section 456.074(5)(u), Florida Statutes (2023), includes a violation

of section 827.071(5)(a), relating to sexual performance by a child.

4. Dr. Friedenthal committed acts that constitute violations of section

827.071(5)(a), Florida Statutes, relating to sexual performance by a child.

5. Section 456.074(5)(u), Florida Statutes (2023), states the

Department shall issue an emergency order suspending the license of any

health care practitioner who is arrested for committing or attempting, soliciting,

or conspiring to commit any act that would constitute a violation of section

827.071(5)(a), Florida Statutes, relating to sexual performance by a child.

6. Dr. Friedenthal was arrested for committing an act that constitutes

a violation of section 827.071(5)(a), Florida Statutes, sexual performance by a

child.

7. The Department is mandated to summarily suspend Dr.

Friedenthal's license to practice as a medical doctor in accordance with section

456.074(5)(u).

WHEREFORE, in accordance with sections 120.60(6) and 456.074(5)(u), it is **ORDERED THAT**:

- 1. The license of Steven B. Friedenthal, M.D., to practice medicine in the State of Florida, license number ME 56709, is immediately suspended.
- 2. A proceeding seeking formal discipline of the license of Dr. Friedenthal to practice as a physician in the State of Florida will be promptly instituted and acted upon in compliance with sections 120.569 and 120.60(6), Florida Statutes (2024).
