## CLOSING ORDER

THE COMPLAINT: Complainant alleges that the Subject of the investigation failed to maintain written medical records justifying the course of treatment of a patient, in that Subject failed to provide Complainant's medical records when served with a lawfully issued subpoena duces tecum.

THE FACTS: Investigation substantiated the allegation, and the Probable Cause Panel of the Board of Osteopathic Medical Examiners authorized an Administrative Complaint. Subsequent investigation has revealed that Subject is not in possession of Complainant's patient records.

THE LAW: Based on the foregoing, there is sufficient evidence to support a finding of probable cause that Subject is in violation of Section 459.015(1)(n), Florida Statutes (1985), now Section 459.015(1)(p), Florida Statutes (Supp. 1986). However, under the circumstances of this case, Subject will be issued a Letter of Guidance.

It is, therefore, ORDERED that this case should be, and the same is hereby closed with a Letter of Guidance.
