ORDER OF SUMMARY SUSPENSION

1.

WHEREAS, DAVID M. BATTISTA, M.D. ("Respondent") was licensed by the Georgia Composite Medical Board ("Board") to practice as a physician in the State of Georgia on or about June 8, 2012 and his license expires December 31, 2013.

2.

WHEREAS, on or about May 13, 2013, based on concerns about Respondent's ability to practice medicine safely and his ability to understand the laws and rules of the Board concerning the practice of pain management, the Board issued an Order for Mental/Physical Examination which required Respondent to obtain a mental/physical examination and provide the results to the Board within seven (7) days from the date of service of the Order or to provide a release for the results of a substantially equivalent evaluation conducted no more than thirty (30) days prior to the date of service of the Order. The Order for Mental/Physical Examination was served upon Respondent on or about May 16, 2013.

3.

WHEREAS, the Respondent has not provided the results of a mental/physical examination to the Board nor has the Respondent provided a release for the results of a substantially equivalent evaluation to the Board.

NOW THEREFORE, the Board finds that summary suspension of Respondent's license to practice as a physician in the State of Georgia is warranted under O.C.G.A. § 50-13-18(c)(1), and hereby ORDERS that Respondent's license to practice as a physician in the State of Georgia be and is hereby SUMMARILY SUSPENDED pending further proceedings on behalf of the Board.

If the Respondent wishes to have an expedited hearing, Respondent shall execute and file with the Georgia Composite Medical Board the original and one copy of the attached REQUEST FOR EXPEDITED HEARING no later than fourteen (14) days from the day of service or receipt of this Order. Respondent also shall serve a copy of such REQUEST upon counsel for the Board as identified in the REQUEST.
