INFORMAL SETTLEMENT

COMES NOW the Iowa Board of Medical Examiners (the Board) and Ann M. Kooiker, MD (the Respondent), and pursuant to Iowa Code sections 17A.10 and 272C.3(4), enter into the following Informal Settlement of the contested case currently on file against the Respondent:

- I: The Respondent was issued license number 22552 to practice medicine and surgery in Iowa on July 1, 1981.
- II: A Complaint and Statement of Charges was filed against the Respondent on May 18, 1995. The Complaint and Statement of Charges is awaiting hearing.
 - III: The Board has jurisdiction of the parties and subject matter of the Complaint and Statement of Charges.
 - IV: The Respondent admits the allegations contained in the Complaint and Statement of Charges.
- V: Upon the Board's approval of this Informal Settlement, the Respondent's medical license shall be on probation for an indefinite period of time under the following terms and conditions:
 - A) While engaged in the practice of medicine in Minnesota the Respondent shall comply with all the terms and conditions of the STIPULATION AND ORDER which the Respondent entered into with the Minnesota Board of Medical Practice on or about July 13, 1993. A copy of the order is attached as Exhibit \underline{A} .
 - B) Should the Respondent elect to engage in the practice of medicine in Iowa the Respondent shall, not less than fifteen (15) days prior to beginning practice, notify the Board in writing of her intended practice location.
 - C) Upon beginning practice in Iowa the Respondent shall:
 - (1) Abstain from the use of alcohol.

(2) Abstain from the use of any controlled or prescription drug except those prescribed for her use by another duly licensed treating physician or other duly licensed treating health care professional. Prior to receiving any controlled or prescription drug the Respondent shall

make the treating physician or other treating health care professional aware of her history of chemical abuse.

- (3) Within thirty (30) days of beginning practice in Iowa the Respondent shall provide to the Board the names and curriculum vitae of three physicians or counselors. The Board may choose one of the three to supervise the Respondent's aftercare. As a condition of approval the physician or counselor chosen shall agree to provide reports concerning the Respondent's aftercare to the Board not later than January 20, April 20, July 20 and October 20 of each year of the Respondent's probation or upon request.
- (4) The Respondent shall file reports with the Board attesting to her compliance with the terms and conditions of probation not later that January 10, April 10, July 10 and October 10 of each year of her probation or upon request.
- (5) The Respondent shall provide witnessed blood or urine specimens upon demand by an agent of the Board. The blood or urine specimens shall be used for drug and alcohol testing, all costs of which shall be borne by the Respondent.
- (6) The Respondent shall attend at least one (1) meeting of Alcoholics Anonymous (AA), Narcotics Anonymous (NA) or a similar organization approved by the Board weekly.
 - (a) The Respondent shall obtain a written statement signed or initialed by another person in attendance at each AA, NA or other Board approved meeting which she attends. The statement shall show the date, time and location of the meeting attended.
 - (b) The statements of the Respondent's attendance at the meetings of AA, NA or other Board approved organization shall be attached to the quarterly reports submitted by the Respondent as required herein.
- (7) The Respondent shall obey all federal, state and local laws and all rules governing the practice of medicine in Iowa.
- (8) During the period of probation the Respondent shall not be eligible to supervise physician assistants.
- VI: If the Respondent violates or fails to comply with any of the terms or conditions of this Informal Settlement, the Board may initiate appropriate action to revoke or suspend the Respondent's license or to impose other licensee discipline as authorized in Iowa Code Chapters 272C and 148 and 653 IAC 12.2.

VII: The Respondent shall not seek termination of the terms and conditions of this Informal Settlement until she has been released from the terms and conditions of the Stipulation and Order referred to in paragraph 5) A) herein.

VIII: Upon full compliance with the terms and conditions set forth in this Informal Settlement and upon further order of the Board, the Respondent's license shall be restored to its full privileges free and clear of the terms of probation.

IX: This Informal Settlement is subject to approval by the Board. If the Board fails to approve this Informal Settlement it shall be of no force or effect upon either party.

COMES NOW Ann M. Martino, PhD, Executive Director of the Iowa State Board of Medical Examiners (hereafter the Board), on May 18, 1995, and at the direction of the Board, files this Complaint and Statement of Charges against Ann M. Kooiker, MD (hereafter the Respondent), a physician licensed pursuant to Chapter 147 of the Code of Iowa and alleges:

- 1. That Edra Broich; James Caterine, MD; James D. Collins, Jr., MD; Eddie D. DeHaan, MD; Mary C. Hodges; Dale R. Holdiman, MD; Teresa Ann Mock, MD; Donna Norman, DO; Roger F. Senty, DO; and, Laura J. Stensrud, are the duly appointed, qualified and acting members of the Board.
- That the Respondent was issued license number 22552 to practice medicine and surgery in Iowa on July 1, 1981, as recorded in the permanent records in the office of the Board.
 - 3. That the Respondent's license next expires on September 1, 1996.
- That on or about July 13, 1993, the Respondent entered into a voluntary Stipulation and Order with the Minnesota Board of Medical Practice. The Stipulation and Order placed restrictions on the Respondent's Minnesota medical license. A copy of the Stipulation and order is attached as Exhibit A.
- That the Board is authorized to take disciplinary action against the 5. Respondent pursuant to the provisions of section 148.12 of the 1995 Code of Iowa, which states in part:
 - medical Voluntary Agreements. The 148.12 examiners, after due notice and hearing may issue an order to revoke, suspend, or restrict a license to practice medicine

and surgery ... if the medical examiners determine that a physician licensed to practice medicine and surgery ... has entered into a voluntary agreement to restrict the practice of medicine and surgery ... in another state ...

6. That paragraph 5 constitutes grounds for the Board to revoke, suspend or restrict the license to practice medicine and surgery issued to the Respondent on July 1, 1981.

WHEREFORE the undersigned charges that the Respondent is subject to disciplinary action pursuant to the provisions of section 148.12 of the 1995 Code of Iowa. The undersigned prays that the Board enter an order fixing a time and place of hearing for the Complaint and Statement of Charges. The undersigned further prays that upon final hearing, the Board enter its findings of fact and decision to revoke, suspend or restrict the license to practice medicine and surgery issued to the Respondent on July 1, 1981 and for such other relief as the Board deems just in the premises.
