**SETTLEMENT AGREEMENT**

COMES NOW the Iowa Board of Medicine (Board) and William A. Stutts, D.O., (Respondent), and on July 10, 2015, and pursuant to Iowa Code sections 17A.10(2) and 272C.3(4) enter into this Settlement Agreement to resolve the contested case currently on file.

**STATEMENT OF THE MATTERS ASSERTED**

1. Respondent was issued Iowa medical license no. 03253 on September 20, 1999.
2. Respondent's Iowa medical license went inactive due to nonrenewal on November 1, 2012.
3. The Board has jurisdiction in this matter pursuant to Iowa Code Chapters 147, 148 and 272C.

4. **PRACTICE SETTING:** Respondent is an Iowa-licensed physician who formerly practiced psychiatry in Cedar Rapids, Iowa.

5. **STATEMENT OF CHARGES:** On July 19, 2012, Respondent entered into an initial agreement with the Iowa Physician Health Program (IPHP) due to concerns that he suffered from a medical disability. On December 20, 2013, the Board filed charges against Respondent due to concerns that he failed to fulfill the requirements established by the IPHP and he suffers from a medical disability which impairs his ability to practice medicine with reasonable skill and safety.

#### SETTLEMENT AGREEMENT

6. **VOLUNTARY SURRENDER:** Recently, Respondent contacted the Board and indicated that he has retired from the practice of medicine because he suffers from a medical disability which impairs his ability to practice medicine with reasonable skill and safety. Respondent voluntarily surrenders his Iowa medical license because he can no longer practice medicine.

7. Respondent voluntarily submits this Order to the Board for consideration.

8. Respondent agrees that the State's counsel may present this Order to the Board for consideration.

9. This Order constitutes the resolution of a contested case proceeding.

10. Respondent understands that by entering into this Order, he has a right to legal counsel in this matter, voluntarily waives any rights to a contested case hearing on the

allegations in the Statement of Charges, and waives any objections to the terms of this Order.


11. Respondent shall obey all federal, state and local laws, and all rules governing the practice of medicine in Iowa.

12. Respondent understands that the Board is required by Federal law to report this Order to the National Practitioner Data Bank.

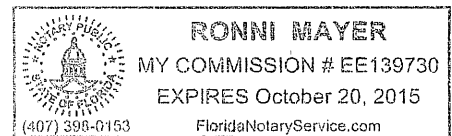
13. The Order becomes a public record available for inspection and copying upon execution in accordance with the requirements of Iowa Code Chapters 17A, 22 and 272C.

**STATEMENT OF CHARGES**

\*\*\*\*\*

COMES NOW the Iowa Board of Medicine (Board) on December 20, 2013, and files this Statement of Charges pursuant to Iowa Code Section 17A.12(2). Respondent was issued Iowa medical license no. 03253 on September 20, 1999. Respondent's Iowa medical license went inactive due to nonrenewal on November 1, 2012.

**A. TIME, PLACE AND NATURE OF HEARING**

1. Hearing. A disciplinary contested case hearing shall be held on February 20, 2014, before the Iowa Board of Medicine. The hearing shall begin at 8:30 a.m. and shall be located in the conference room at the Iowa Board of Medicine office at 400 SW 8<sup>th</sup> Street, Suite C, Des Moines, Iowa.

2. Answer. Within twenty (20) days of the date you are served this Notice of Hearing you are required by 653 Iowa Administrative Code 25.10 to file an Answer. In that Answer, you should also state whether you will require a continuance of the date and time of the hearing.

3. Presiding Officer. The Board shall serve as presiding officer, but the Board may request an Administrative Law Judge make initial rulings on prehearing matters, and be present to assist and advise the board at hearing.

4. Prehearing Conference. A prehearing conference will be held by telephone on January 15, 2014, at 9:30 a.m., before an Administrative Law Judge from the Iowa Department of Inspections and Appeals (ALJ). Please contact Kent M. Nebel, J.D., Legal Director, Iowa Board of Medicine, at 515-281-7088 with the telephone number at which you or your legal counsel can be reached. Board rules on prehearing conferences may be found at 653 Iowa Administrative Code 25.15.

5. Hearing Procedures. The procedural rules governing the conduct of the hearing are found at 653 Iowa Administrative Code Chapter 25. At hearing, you will be allowed the opportunity to respond to the charges against you, to produce evidence on your behalf, cross-examine witnesses, and examine any documents introduced at hearing. You may appear personally or be represented by counsel at your own expense. If you need to request an alternative time or date for hearing, you must review the requirements in 653 Iowa Administrative Code 25.16. The hearing may be open to the public or closed to the public at the discretion of the Respondent.

6. Prosecution. The office of the Attorney General is responsible for representing the public interest (the State) in this proceeding. Pleadings shall be filed with the Board and copies should be provided to counsel for the State at the following address: Julie Bussanmas, Assistant Attorney General, Iowa Attorney General's Office, 2<sup>nd</sup> Floor, Hoover State Office Building, Des Moines, Iowa 50319.

7. Communications. You may not contact board members by phone, letter, facsimile, e-mail, or in person about this Notice of Hearing. Board members may only receive information about the case when all parties have notice and an opportunity to participate, such as at the hearing or in pleadings you file with the Board office and serve upon all parties in the case. You may contact Kent M. Nebel, J.D., Legal Director, at 515-281-7088 or to Assistant Attorney General Julie Bussanmas at 515-281-5637.

## **B. LEGAL AUTHORITY AND JURISDICTION**

8. Jurisdiction. The Board has jurisdiction in this matter pursuant to Iowa Code Chapters 17A, 147, 148, and 272C.

9. Legal Authority: If any of the allegations against you are founded, the Board has authority to take disciplinary action against you under Iowa Code Chapters 17A, 147, 148, and 272C (2005) and 653 Iowa Administrative Code Chapter 25.25.

10. Default. If you fail to appear at the hearing, the Board may enter a default decision or proceed with the hearing and render a decision in your absence, in accordance with Iowa Code Section 17A.12(3) and 653 Iowa Administrative Code 25.20.

## **C. SECTIONS OF STATUTES AND RULES INVOLVED**

### **COUNT I**

11. **VIOLATION OF A PHYSICIAN HEALTH CONTRACT:** Respondent is charged pursuant to Iowa Code section 272C.3(k) and 653 IAC 23.1(12) with violating an initial agreement or physician health contract that he entered into with the Iowa Physician Health Program (IPHP).

### **COUNT II**

12. **PHYSICAL, NEUROPSYCHOLOGICAL OR MENTAL IMPAIRMENT:** Respondent is charged pursuant to Iowa Code section 148.6(2)(h) and 653 IAC 23.1(8) with suffering from physical, neuropsychological, or mental condition which may impair a physician's ability to practice medicine with reasonable skill and safety.

### **STATEMENT OF THE MATTERS ASSERTED**

13. Respondent is an Iowa-licensed physician who formerly practiced psychiatry in Cedar Rapids, Iowa.

14. On July 19, 2012, Respondent entered into an initial agreement with the Iowa Physician Health Program (IPHP) due to concerns about his health.

15. The Board alleges that Respondent failed to fully comply with the terms established by the IPHP.

16. The Board alleges that Respondent suffers from a physical, neuropsychological, or mental condition which may impair his ability to practice medicine with reasonable skill and safety.



#### **E. SETTLEMENT**

17. Settlement. This matter may be resolved by settlement agreement. The procedural rules governing the Board's settlement process are found at 653 Iowa Administrative Code 12.25. #### **F. PROBABLE CAUSE FINDING**

18. On December 20, 2013, the Iowa Board of Medicine found probable cause to file this Statement of Charges.
