ORDER

- THAT the aforesaid conduct is grounds to refuse to renew Respondent's License as a Physician and Surgeon under 225 ILCS 60/22(A)(12).
- THAT I have jurisdiction of the parties and subject matter pursuant to 225 Illinois Compiled Statutes Section 60/22(A), et seq.

IT IS ORDERED that Rehana Aziz, M.D.'s Physician and Surgeon License SHALL NOT BE RENEWED as of the date of this Order.

BE NOTIFIED that the Department of Financial and Professional Regulation of the State of Illinois (Department) has received information that your Physician and Surgeon License was disciplined by the State of California. The Department has jurisdiction to investigate this discipline and bring this action pursuant to the Medical Practice Act, 225 Illinois Compiled Statutes, Section 60/36.

YOU ARE FURTHER NOTIFIED that you have the right to request a hearing to address the issues that give rise to placing your Physician and Surgeon License in Refuse to Renew status. You shall have 30 days from the date of this notice to make a written request for a hearing. Failure to request a hearing within 30 days will result in the entry of the Order of Refusal to Renew your

Physician and Surgeon License. Your request for a hearing should be directed to the Clerk of the Court, Illinois Department of Financial and Professional Regulation, 100 W. Randolph St., Suite 9-300, Chicago, IL 60601


