COMPLAINT

Comes now the Complainant Dale E. Toney, M.D., Chair of the Kentucky Board of Medical Licensure's Inquiry Panel B, and on behalf of the Panel which met on November 18, 2021, states for its Complaint against the licensee, GLADYS R. GREGORY, M.D., as follows:


1. At all relevant times, Gladys R. Gregory, M.D. ("the licensee"), was licensed by the Board to practice medicine within the Commonwealth of Kentucky.
2. The licensee's medical specialty is Psychiatry.
3. The licensee is also licensed by the Tennessee Board of Medical Examiners ("Tennessee Board") to practice medicine in the state of Tennessee.
4. On or about September 22, 2021, the Tennessee Board issued a Final Order regarding the medical license held by the licensee.
5. The Tennessee Board found that the licensee violated the Tennessee Medical Practice Act by offering discounts to patients in exchange for recruitment of other patients.
6. The Tennessee Board imposed the following discipline in the Final Order:
 - a. The licensee is issued a Letter of Warning;
 - b. The licensee shall pay a fine of five hundred (\$500.00) dollars within thirty (30) days of the execution of the Order; and

- c. The licensee must enroll in and successfully complete the two (2) day medical course entitled “Medical Ethics, Boundaries & Professionalism” offered at the Case Western Reserve University Continuing Medical Education Program, or an equivalent course approved in advance by the Board’s Medical Consultant, within one (1) year of the effective date of the Order.
7. The Board received notice of the Tennessee Board action via a grievance filed by the Citizens Commission on Human Rights of Nashville and via report from the Federation of State Medical Boards. The licensee did not report the disciplinary action taken by the Tennessee Board within ten days of the September 22, 2021 Order as required by 201 KAR 9:081(9)(2)(a)(2). Further, the licensee did not provide this Board a copy of the order issued by the Tennessee Board within ten days of the September 22, 2021 Order.
8. By her conduct, the licensee has violated the provisions of KRS 311.595(12) and (17). Accordingly, legal grounds exist for disciplinary action against her Kentucky medical license.
9. The licensee is directed to respond to the allegations delineated in the Complaint within thirty (30) days of service thereof and is further given notice that:
 - (a) Her failure to respond may be taken as an admission of the charges;
 - (b) She may appear alone or with counsel, may cross-examine all prosecution witnesses and offer evidence in her defense.
10. NOTICE IS HEREBY GIVEN that a hearing on this Complaint is scheduled for May 24, 2022 at 9:00 a.m., Eastern Standard Time, at the Kentucky Board of Medical Licensure, Hurstbourne Office Park, 310 Whittington Parkway, Suite 1B,

Louisville, Kentucky 40222. Said hearing shall be held pursuant to the Rules and Regulations of the Kentucky Board of Medical Licensure and pursuant to KRS Chapter 13B. This hearing shall proceed as scheduled and the hearing date shall only be modified by leave of the Hearing Officer upon a showing of good cause.

WHEREFORE, Complainant prays that appropriate disciplinary action be taken against the license to practice medicine held by GLADYS R. GREGORY, M.D.
