On or about on July 24, 2015, Albert Norman Bayer, M.D. (Petitioner) filed

with the Michigan Board of Medicine (Board) an application for reinstatement of his

license to practice medicine in the state of Michigan with supporting documents, in

accordance with the provisions of Mich Admin Code, R 792.10711.

On September 29, 2015, the Department of Attorney General, Licensing

and Regulation Division, on behalf of the Department of Licensing and Regulatory

Affairs, Bureau of Professional Licensing (Department), filed a response in opposition to

Petitioner's application for reinstatement.

An administrative hearing was held in this matter before an administrative

law judge who, on May 5, 2016, issued a Proposal for Decision setting forth

recommended Findings of Fact and Conclusions of Law.

The Board, having reviewed the administrative record, considered this

matter at a regularly scheduled meeting held in Lansing, Michigan on July 20, 2016, and

accepted the administrative law judge's Findings of Fact and Conclusions of Law

contained in the Proposal for Decision. Therefore,

IT IS ORDERED that Petitioner's application for reinstatement of the

license to practice medicine is DENIED, as Petitioner has failed to satisfy the

requirements for reinstatement pursuant to sections 16245 and 16247 of the Public

Health Code, supra, and the guidelines on reinstatement adopted by the Department.
