Dear Dr. Prasad:

The members of the Missouri State Board of Registration for the Healing Arts reviewed your application for permanent licensure during their most recent meeting.

The Board directed that your application for licensure be denied pursuant to the provisions of Section 334.103.2 RSMo. which state, in pertinent part, as follows:

"334.103.2. Anyone who has been denied a license, permit or certificate to practice in another state shall automatically be denied a license to practice in this state. However, the board of healing arts may set up other qualifications by which such person may ultimately be qualified and licensed to practice in Missouri."

The information you provided in your application for a Missouri license states that you were denied a permit by the Oklahoma State Board of Medical Licensure and Supervision.

However, it was also the Board's decision to advise you that upon receipt of proof of successful completion of your fellowship at the University of Kansas Medical Center they will accept this as demonstration of "other qualifications" by which you may apply for a license to practice in the State of Missouri.

If you wish to contest the Board's decision and believe you are entitled to a license, you may file a formal complaint with the Administrative Hearing Commission pursuant to Chapter 621, RSMo. The Administrative Hearing Commission will hold a formal adversary hearing at which time you may be represented by an attorney. It will be incumbent on you to prove by admissible evidence that you are entitled to a license. According to Section 621.120, you must file the complaint "within thirty days after the delivery or mailing by certified mail" of this notice. You may contact the Administrative Hearing Commission at P. O. Box 1557, Jefferson City, Missouri 65102.
