This matter is before the North Carolina Medical Board (hereafter Board) on the application of Carol Ann Martin, M.D. (hereafter Dr. Martin), for a license to practice medicine and surgery in North Carolina. The Board finds and concludes, and Dr. Martin admits, the following:

Whereas pursuant to a Consent Order dated December 13, 1995, between Dr. Martin and the Rhode Island Board of Medical Licensure and Discipline (hereafter the Rhode Island Board), a copy of which is attached hereto, Dr. Martin voluntarily surrendered her license to practice medicine in the State of Rhode Island while charges were pending against her alleging that she engaged in a sexual relationship with a patient and that she was impaired to the degree that she was unable to treat patients with a reasonable degree of skill and safety, and

Whereas last year the Rhode Island Board reinstated Dr. Martin's license subject to numerous conditions, and

Whereas the foregoing constitutes grounds, pursuant to N.C. Gen. Stat. § 90-14(a)(13), for the Board to deny Dr. Martin's application for a license to practice medicine and surgery in North Carolina, and

Whereas on June 2, 1999, Dr. Martin signed a contract with the North Carolina Physicians Health Program (hereafter NCPHP), and

Whereas Dr. Martin participates in outpatient treatment with Dr. Landrum Tucker on a bimonthly basis to address boundary issues and her mental health, and

Whereas Dr. Martin met with members of the Board on November 20, 1999, to discuss the above, and

Whereas Dr. Martin has taken steps and has agreed to take further steps to ensure to the Board and the people of North Carolina that she can safely practice medicine;

Now, therefore, with Dr. Martin' consent, it is ORDERED that:

- The Board shall issue Dr. Martin a license to expire on the date shown thereon.
- Dr. Martin's practice shall be limited to psychiatry and sleep disorders.
 - 3. Dr. Martin may not work more than ten hours per week.
 - 4. Dr. Martin may not work in a solo practice.
 - 5. Dr. Martin shall obtain a clinical supervisor who will

regularly review Dr. Martin's cases. Dr. Martin shall direct the clinical supervisor to send quarterly reports regarding these cases to the Director of Investigations, North Carolina Medical Board, PO Box 20007, Raleigh, NC 27619, so that the reports are received not later than January 1, April 1, July 1, and October 1 of each year beginning with a report due not later than April 1, 2000.

- 6. Dr. Martin may not, either as a primary or a back-up physician, supervise physician assistants or nurse practitioners.
- 7. At her own expense, Dr. Martin shall continue her therapy with Dr. Tucker, or such other therapist as may be approved in writing by the President of the Board, and shall comply with all recommendations made by him.
- 8. Dr. Martin shall direct Dr. Tucker, or his successor, to send quarterly reports to the Director of Investigations, North Carolina Medical Board, PO Box 20007, Raleigh, NC 27619, so that it is received not later than January 1, April 1, July 1, and October 1 of each year beginning with a report due not later than January 1, 2000.
- 9. Dr. Martin shall maintain a contract with the NCPHP and abide by its terms, including the payment of any required fees.

- 10. Dr. Martin shall obtain and document to the Board fifty (50) hours of Category I continuing medical education directly relevant to her practice each calendar year beginning with 2000.
- 11. Dr. Martin shall obey all laws. In addition, Dr. Martin shall obey all regulations related to the practice of medicine.
- 12. Dr. Martin shall notify the Board in writing of any change in her residence or practice addresses within ten (10) days of the change.
- 13. Dr. Martin shall appear before the Board at its March 2000 meeting, and at such other times as requested by the Board, for an informal interview.
- 14. If Dr. Martin fails to comply with any of the terms of this Consent Order, that failure shall constitute unprofessional conduct within the meaning of N.C. Gen. Stat. § 90-14(a)(6) and shall be grounds, after any required notice and hearing, for the Board to deny any application she might make in the future or then have pending for a license.
- 15. This Consent Order shall take effect immediately upon its execution by both Dr. Martin and the Board, and it shall continue in effect until specifically ordered otherwise by the Board.
- 16. Dr. Martin hereby waives any requirement under any law or rule that this Consent Order be served on her.

17. Upon execution by Dr. Martin and the Board, this Consent Order shall become a public record within the meaning of Chapter 132 of the North Carolina General Statutes and shall be subject to public inspection and dissemination pursuant to the provisions thereof. Additionally, it will be reported to persons, entities, agencies, and clearinghouses as required by and permitted by law including, but not limited to, the Federation of State Medical Boards, the National Practitioner's Data Bank, and the Healthcare Integrity and Protection Data Bank.
