Dear Dr. Sinn:

The Board has concluded its inquiry regarding your treatment of patients for both psychiatric and chronic pain. It is the Board's decision not to commence formal proceedings against your license to practice medicine at this time. However, the Board did vote to issue you a public letter of concern.

Based on the information it reviewed and the submission of the records of five of your patients to a reviewing expert, the Board is concerned that it appears that your diagnosis, treatment, and documentation may have failed to conform to the standard of care in North Carolina. In addition, the Board is also concerned about your physical well-being and how it may affect you ability o safely practice medicine. The Board does note that you have voluntarily made your North Carolina license inactive.

By this letter, the Board cautions you that should you decide to seek reinstatement of your North Carolina medical license, the Board will expect you to have addressed the matters mentioned above. The Board further cautions you that complaints disclosing any repetition of such practice may lead to the commencement of formal disciplinary proceedings against your license to practice medicine, wherein this public letter of concern may be entered into evidence as aggravation. The Board does not consider a public letter of concern to constitute disciplinary action, nor does it constitute a restriction or limitation on your license to practice medicine.

This public letter of concern shall become a public record within the meaning of Chapter 132 of the North Carolina General Statutes and shall be subject to public inspection and dissemination pursuant to the provisions thereof. Additionally, it will be reported to the Federation of State Medical Boards. It will not be reported to the National Practitioner Data Bank or the Healthcare Integrity and Practitioner Data Bank.
