This matter is before the North Carolina Medical Board ("Board") regarding information provided to the Board concerning Chad Daniel Howard, M.D., ("Dr. Howard"). Dr. Howard makes the following admissions and the Board makes the following findings and conclusions:

STATUTORY AUTHORITY

The Board is a body duly organized under the laws of North Carolina and is the proper party to bring this proceeding under the authority granted it in Article 1 of Chapter 90 of the North Carolina General Statutes and the rules and regulations promulgated thereto.

FINDINGS OF FACT

Dr. Howard was first issued a license to practice medicine and surgery by the Board on or about February 21, 2002, license number 200200125.

At all times relevant hereto, Dr. Howard practiced medicine in Elizabeth City, North Carolina.

On October 8, 2016, and while on his way to work as a hospitalist at the local hospital, Dr. Howard was involved in a one car motor vehicle accident in Elizabeth City, North Carolina. When law enforcement arrived at the scene of the accident, Dr. Howard appeared intoxicated. Dr. Howard admitted to drinking alcohol and had a positive blood alcohol content on a mobile Intoxilyzer device. Dr. Howard was charged with Driving While Impaired.

During the course of the Board's investigation, it was revealed that Dr. Howard did have one workplace incident where a nurse reported Dr. Howard smelling of alcohol.

Dr. Howard reported to the North Carolina Physicians Health Program ("NCPHP"). The NCPHP referred Dr. Howard for a comprehensive assessment. The assessment indicates Dr. Howard suffers from Substance Use Disorder Severe (alcohol). Dr. Howard has presented for inpatient treatment for his Substance Use Disorder.

On December 19, 2016, Dr. Howard voluntarily surrendered his North Carolina medical license.

CONCLUSIONS OF LAW

By consuming alcohol to the point of intoxication immediately prior to his shift at the hospital, Dr. Howard engaged in unprofessional conduct including, but not limited to, departure from, or the failure to conform to, the ethics of the medical

profession, or the commission of an act contrary to good honesty, justice or good morals, within the meaning of N.C. Gen. Stat. § 90-14(a)(6), and grounds exist under this section of the North Carolina General Statutes for the Board to annul, suspend, revoke, condition or limit Dr. Howard's license to practice medicine or to deny any application he might make in the future.

Dr. Howard suffers from a health condition that, when left untreated, renders him unable to practice medicine with reasonable skill and safety to patients within the meaning of N.C. Gen. Stat. § 90-14(a)(5), and grounds exist under this section of the North Carolina General Statutes for the Board to annul, suspend, revoke, condition or limit Dr. Howard's license to practice medicine or to deny any application he might make in the future.

PROCEDURAL STIPULATIONS

- Dr. Howard acknowledges and agrees that the Board has jurisdiction over him and over the subject matter of this case.
- Dr. Howard knowingly waives his right to any hearing and to any judicial review or appeal in this case.
- Dr. Howard acknowledges that he has read and understands this Consent Order and enters into it voluntarily.
- Dr. Howard desires to resolve this matter without the need for more formal proceedings.

The Board has determined that it is in the public interest to resolve this case as set forth below.

ORDER

NOW, THEREFORE, with Dr. Howard's consent, it is ORDERED that:

1. Dr. Howard's North Carolina license to practice medicine

and surgery is hereby INDEFINITELY SUSPENDED.

2. This Consent Order shall take effect immediately upon

its execution by both Dr. Howard and the Board and it shall

continue in effect until specifically ordered otherwise by the

Board.

3. Dr. Howard hereby waives any requirement under any law

or rule that this Consent Order be served on him.

4. Upon execution by Dr. Howard and the Board, this Consent

Order shall become a public record within the meaning of Chapter

132 of the North Carolina General Statutes and shall be subject to

public inspection and dissemination pursuant to the provisions

thereof. Additionally, it will be reported to persons, entities,

agencies and clearinghouses as required and permitted by law

including, but not limited to, the Federation of State Medical

Boards and the National Practitioner Data Bank.
