- 3. During a period of time in 1975, you engaged in unprofessional conduct with a female, identified to you as Witness Number 2, as defined in North Carolina General Statutes 90-14(6), during a period of time when she was rendered professional services and advice by you.

4. During a period of time in 1976 and 1977, you engaged in unprofessional conduct with a female identified to you as Witness Number 2, as defined in North Carolina General Statutes 90-14(6), after a period of time when she was rendered professional services and advice by you.

You are further given notice that a hearing concerning the foregoing charges will be held before the Board of Medical Examiners of the State of North Carolina at the Sheraton Highwoods Hotel, Hwy. U.S. I North, Raleigh, North Carolina, on the 13th day of June, 1983, at 1:00 o'clock, p.m., at which time you will be given an opportunity to appear in person and by counsel, to cross-examine witnesses, and to present evidence on your own behalf. In the meantime, you may file a written response to the foregoing charges within thirty (30) days if you so desire.

THIS MATTER came on for hearing before the Board of Medical Examiners of the State of North Carolina ("Board") on June 9, 1984 upon a certain "Notice of Charges and Allegations" dated March 23, 1983. Respondent, and counsel on his behalf, appeared at the hearing. Based upon the evidence presented at the hearing, the Board makes the following:

#### FINDINGS OF FACT

- 1. Respondent engaged in unprofessional conduct, as defined in North Carolina General Statutes Section 90-14(a)(6), with a female identified as Witness Number 1 during a period of time in 1981 when she was rendered professional services and advice by respondent.
- 2. Respondent engaged in unprofessional conduct, as defined in North Carolina General Statutes Section 90-14(a)(6), with a female identified as Witness Number 1 during a period of time in 1981 after she was rendered professional services and advice by respondent.

- 3. Respondent engaged in unprofessional conduct, as defined in North Carolina Ceneral Statutes Section 90-14(a)(6), with a female identified as Witness Number 2 during a period of time in 1975 when she was rendered professional services and advice by respondent.
- 4. Respondent engaged in unprofessional conduct, as defined in North Carolina General Statutes Section 90-14(a)(6), with a female identified as Witness Number 2 during a period of time in 1976 and 1977 after she was rendered professional services and advice by respondent.

#### CONCLUSIONS OF LAW

Grounds exist, under North Carolina General Statutes Section 90-14(a)(6) for the revocation of the license to practice medicine issued to the respondent by the Board.

NOW, THEREFORE, IT IS ORDERED, that respondent's license to practice medicine in North Carolina is hereby revoked, with such revocation suspended upon respondent's compliance with the following conditions:

- That for a period of five years respondent violate no state or federal law;
  - 2. That respondent abstain from unethical conduct;
- 3. That respondent abstain from the personal use of mind-altering chemicals unless prescribed by another physician or dentist in the normal course of medical or dental treatment;

- That respondent obtain psychiatric therapy from a psychiatrist other than Dr. Richard Faw, that such psychiatric therapy continue for a period of at least five years, and that respondent furnish the Board with psychiatric reports annually or on a more frequent basis if so requested by the Board:
- That respondent appear periodically, as the Board may request, for interviews with the Board.

Whereas, on May 4, 1989, Robert Richard Ratcliffe, III, M.D. ("Respondent") met informally with the Board of Medical Examiners of the State of North Carolina ("Board") pursuant to provision number five (5) of the Order of the Board entered on July 9, 1984; and

Whereas, Respondent admitted that he wrote at least one prescription for himself for a mind altering chemical in violation of provision number three (3) of the Order of the Board entered on July 9, 1984; and

Whereas, matters relating to his medical practice, including the prescribing of controlled substances without adequate examination of patients, were discussed with the Board; and

Whereas, the preceding would constitute a violation of North Carolina General Statutes section 90-14(a)(6); and

Whereas, Respondent wishes to resolve this matter without need for a formal hearing and the Board has determined that the public interest would be served by so resolving this matter.

Now, therefore, with the consent of Respondent freely given, it is ORDERED that:

1. The suspension of the revocation of Respondent's license to practice medicine in the State of North Carolina pursuant to the Order of the Board dated July 9, 1984 is hereby withdrawn and Respondent's license to practice medicine in North Carolina is hereby revoked.

- 2. Respondent shall surrender his DEA prescribing privileges for Schedules 2, 2N, 3 and 3N.
- 3. Respondent shall dispose in accordance with applicable law of all medications classified in Schedules 2, 2N, 3 and 3N which may be in his possession.
- Respondent shall cooperate with the Board and its representatives in such further monitoring of Respondent's practice as the Board may deem reasonably necessary.
- 5. On the date Respondent executes this Consent Order, the Board shall issue a temporary license permitting Respondent to practice medicine in North Carolina for a period of one (1) year.
- 6. On or before April 15, 1990, Respondent shall provide the Board with documentation of completion of at least fifty (50) hours of Category I continuing medical education in the field of psychiatry obtained after the date of this Consent Order.
- 7. Respondent shall meet informally with the Board during May 1990, at which time the Board shall review twenty (20) patient records of Respondent selected at random by the Board.
- 8. The failure of Respondent to comply with any of the provisions of this Consent Order shall, after proper notice and hearing, be grounds for disciplinary action by the Board against Respondent including, without limitation, revocation of license.
- The entry of this Consent Order and the dissemination thereof shall constitute a public record pursuant to Chapter 132 of the General Statutes of North Carolina.


