Whereas Dr. Eaton had a sexual relationship with one of his patients, and

Whereas that fact is grounds under N.C. Gen. Stat. § 90-14(a)(6) for the Board to annul, suspend, revoke, condition, or limit Dr. Eaton' license to practice medicine in North Carolina, or to deny any application he might make in the future or then have pending for a license to practice medicine, and

Whereas Dr. Eaton surrendered his license to practice medicine on December 1, 1994, and

Whereas Dr. Eaton desires to resolve this matter without need for more formal proceedings, and

Whereas Dr. Eaton has taken steps and has agreed to take further steps to ensure the Board and the people of North Carolina that he can safely practice medicine, and

Whereas the Board has determined that it is in the public interest to resolve this matter as set forth below;

Now, therefore, with Dr. Eaton's consent, it is ORDERED that:

- 1. To the extent he has not already done so, Dr. Eaton will arrange for continuous coverage of the care of patients who will require care continuing beyond the surrender of his license.
- 2. The Board shall issue Dr. Eaton a license to practice medicine effective January 1, 1995, to expire at the end of the day on June 30, 1995.
- 3. Dr. Eaton shall have his counsellor send reports to the Board prior to its May, 1995, meeting.
- 4. Dr. Eaton will appear at an informal interview before the Board or a committee or panel of the Board at its May, 1995, meeting.
- 5. Dr. Eaton shall enter into a contract with the North Carolina Physicians Health Program (NCPHP) and abide by its terms.
- 6. Dr. Eaton shall notify the Board in writing of any change in his residence or practice addresses within ten (10) days of the change.
 - 7. Dr. Eaton shall obey all laws.
- 8. If Dr. Eaton fails to comply with any of the terms of this Consent Order, that failure shall constitute unprofessional conduct and shall be grounds, pursuant to N.C. Gen. Stat. § 90-14(a)(6), after any required notice and hearing, for the Board to annul, suspend, revoke, condition, or limit his license to practice medicine or to deny any application he might make in the future or then have pending for a license to practice medicine.
 - 9. This Consent Order shall take effect immediately upon its

execution by both Dr. Eaton and the Board, and it shall continue in effect until specifically ordered otherwise by the Board.

- 10. Dr. Eaton hereby waives any requirement under any law or rule that this Consent Order be served on him.
- 11. Upon execution by Dr. Eaton and the Board, this Consent Order shall become a public record within the meaning of Chapter 132 of the North Carolina General Statutes and shall be subject to public inspection and dissemination pursuant to the provisions thereof.
