## In re: Michael Dallolio, M.D., North Dakota License Number 10814

## STIPULATION AND NON-PRACTICE AGREEMENT

The parties to this agreement are Michael Dallolio, M.D., a physician holding an active medical license in North Dakota, and the North Dakota Board of Medicine (the Board), through its executive director, Sandra DePountis.

The Board obtained information it considers to be the basis for potential disciplinary action against Dr. Dallolio, which will be reviewed by an Investigative Panel of the Board.

Dr. Dallolio agrees that, upon the execution of this agreement, he will immediately cease the practice of medicine in North Dakota. He further agrees he will not practice medicine in the state until such time as the Board finalizes any disciplinary action that may be brought against him. The Board agrees to promptly advise Dr. Dallolio of the status and disposition of its investigation into this matter.

The parties agree this stipulation is not a disciplinary action, but also agree it does not foreclose a disciplinary action against Dr. Dallolio. The parties agree signing this stipulation is not an admission of fault on the part of Dr. Dallolio.

The parties agree this is a public document for the purpose of the laws governing such documents in the possession of the Board.

The parties agree that, upon execution of this agreement, Dr. Dallolio's North Dakota medical license will be inactive for all purposes, and will be so listed on the Board's public database.

Dr. Dallolio understands and agrees this non-practice agreement is governed by Chapter 43-17, N.D.C.C., and that any violation of its terms is cause for immediate disciplinary action.

Dr. Dallolio agrees he has been afforded the opportunity to have this agreement reviewed by his attorney and that no inducements, threats or promises have been made to obtain his acceptance of this agreement.
