- I, Dominic Losacco, M.D. ("Defendant"), being of lawful age and after first being duly sworn, depose and state as follows:
- 1. I hereby voluntarily surrender my Oklahoma medical license no. 10161, effective October 1, 2019.
- 2. The surrender of my license is freely and voluntarily made. I have not been subject to any coercion or duress, and I am fully aware of the consequences of the surrender of my license.
- 3. I am the subject of a proceeding by the Oklahoma State Board of Medical Licensure and Supervision ("Board") involving allegations which, if proven, would constitute grounds for disciplinary action by the Board.
- 4. I admit that during my practice my charting and record-keeping were inadequate and fell below the standard of care.
- 5. I Dominic Losacco, M.D., am guilty of unprofessional conduct by violating the following rules of professional conduct:

- a. Failure to maintain an office record for each patient which accurately reflects the evaluation, treatment and medical necessity of treatment of the patient in violation of 59 O.S. §509(18).
- b. Adequate medical records to support, diagnosis, procedure, treatment or prescribed medications must be produced and maintained. 59 O.S. §509(20) and Okla. Admin. Code § 435-10-7-4(41).
- c. Improper management of medical records in violation of Okla. Admin. Code § 435-10-7-4(36).
- 6. I hereby submit my wallet card and wall certificate as evidence of my intent to surrender my license. 59 O.S. § 509(E)(2).
- 7. I hereby agree that I will never reapply for reinstatement of my Oklahoma medical license.
- 8. If the Board does not accept this Voluntary Surrender In Lieu of Prosecution the Plaintiff and Defendant (collectively, the "Parties") stipulate that it shall be regarded as null and void. Admissions by Defendant herein, if any, shall not be regarded as evidence against him in a subsequent disciplinary hearing. Defendant will be free to defend himself, and no inferences will be made from his willingness to have this Order accepted by the Board. The Parties stipulate that neither the presentation of the Order nor the Board's consideration of this Order shall be deemed to have unfairly or illegally prejudiced the Board or its individual members and, therefore, shall not be grounds for precluding the Board nor any individual Board member from further participation in proceedings related to the matters set forth herein.
- 9. As a condition to accepting my voluntary surrender of license in lieu of prosecution, I agree to pay the Board the sum of \$3,400.00 for legal fees and costs related to the investigation and proceedings.
