## ORDER STRIKING ITEMS FROM DR. MELTON'S DESIGNATION OF THE RECORD

On May 29, 2025, the Plaintiff/Appellee's Objection to Defendant/Appellant's Designation of Record and Motion to Strike filed on April 11, 2025, came on for hearing before the Oklahoma State Board of Medical Licensure and Supervision ("Board"), at the office of the Board, 101 N.E. 51<sup>st</sup> Street, Oklahoma City, Oklahoma 73105, pursuant to notice given as required by law and the rules of the Board. The parties agreed to have oral argument to the Board en banc, in addition to consideration of written briefs.

Madalynn Martin, Assistant Attorney General (AAG), appeared for the State on behalf of Plaintiff. Edward Gerald Melton, M.D. ("Defendant") appeared *pro se*. Plaintiff and Defendant are collectively referred to herein as the "Parties."

Upon reviewing the Plaintiff/Appellee's Objection to Defendant/Appellant's Designation of Record and Motion to Strike, and upon hearing oral argument, the Board finds as follows:

- In accordance with Oklahoma Supreme Court Rules 1.32 and 1.37, the Board retains jurisdiction to resolve issues concerning the appellate record until the record is transmitted to the Oklahoma Supreme Court. See also the Oklahoma Supreme Court Orders in Case No. 122,926, filed on April 22, 2025, and May 9, 2025.
- 2. Based upon 75 O.S. § 309(F) and Oklahoma Supreme Court Rules 1.76 and 1.33(d), only documents, exhibits, and pleadings before the lower tribunal are proper for inclusion in the record on appeal. Further, the scope of appellate review is limited to those issues decided by the Board in the February 7, 2025 "Order Denying Dr. Melton's Motion to Obtain Copy of Investigative File": The denial of Defendant/Appellant's request for the investigative file and the imposition of costs of the proceedings on Appellant. See also the Oklahoma

Order Striking Items from Dr. Melton's Designation of the Record Edward Gerard Melton, MD 24098; 21-09-6046; Sup.Ct. No. 122,926 Supreme Court Order in Case No. 122,926, filed on April 14, 2025. Thus, Plaintiff/Appellee's Objection is SUSTAINED.

- 3. Clearly she was not talking about Dr. Melton as he never had disciplinary or legal issues in his 17 years of service to the people of Oklahoma
