10	regulating and disciplining certain health care providers, including physicians, in the State of
11	Oregon. Carla Gallati Dorsey, MD (Licensee) is a licensed physician in the State of Oregon.
12	Licensee is no longer practicing medicine in the State of Oregon; her license status became
13	Inactive effective October 1, 2021, and her license changed to lapsed status effective January 1,
14	2022.

16	The Board opened an investigation after receiving credible information regarding
17	Licensee's possible violation of the Medical Practice Act, specifically, self-prescribing
18	controlled substances under a fictitious name.
19	3.
20	Licensee and the Board desire to settle this matter by the entry of this Stipulated Order.
21	Licensee understands that she has the right to a contested case hearing under the Administrative
22	Procedures Act (Oregon Revised Statutes chapter 183), and fully and finally waives the right to a
23	contested case hearing and any appeal therefrom by the signing of and entry of this Order in the
24	Board's records. Licensee neither admits nor denies, but the Board finds that Licensee engaged
25	in conduct that violated the Medical Practice Act, to wit: ORS 677.190(1)(a) unprofessional or
26	dishonorable conduct, as defined in ORS 677.188(4)(a) any conduct, practice or condition which
7	does or might adversely affect a physician's ability to safely and skillfully practice medicine; and

1	ORS 677.190(24) prescribing controlled substances without a legitimate medical purpose.
2	Licensee understands that this Order is a public record and is a disciplinary action that is
3	reportable to the National Practitioner Data Bank and the Federation of State Medical Boards.
4	Licensee understands the terms of this Order and signs freely, without fraud or duress.
5	· 4.
6	Licensee and the Board agree that the Board will close this investigation and resolve this
7	matter by entry of this Stipulated Order, subject to the following conditions:
8	4.1 Licensee surrenders her Oregon medical license while under investigation.
9	4.2 Licensee must not reapply for a medical license in the State of Oregon for at least
10	two years from the effective date of this Order.
11	4.3 Licensee must obey all federal and Oregon state laws and regulations pertaining
12	to the practice of medicine.
13	4.4 Licensee stipulates and agrees that any violation of the terms of this Order shall
14	be grounds for further disciplinary action under ORS 677.190(17).

16	This Order becomes effective the date it is signed by the Board Chair.
