10	regulating and disciplining certain health care providers, including physicians, in the State of
11	Oregon. Khaled Mohamed, MD (Licensee) is a licensed physician in the State of Oregon.

13	On August 30, 2023, the Board opened an investigation after receiving credible
14	information regarding Licensee's possible violation of the Medical Practice Act, specifically his
15	alleged diversion of controlled substances.

17	Licensee and the Board desire to settle this matter by the entry of this Stipulated Order.
18	Licensee understands that he has the right to a contested case hearing under the Administrative
19	Procedures Act (Oregon Revised Statutes chapter 183) and, by the signing and issuance of this
20	Order, Licensee fully and finally waives the right to a contested case hearing, understands and
21	acknowledges that this order is not subject to judicial review, and acknowledges and agrees that
22	this Order was signed freely, without fraud or duress. Licensee neither admits nor denies, but the
23	Board finds that Licensee engaged in conduct that violated the Medical Practice Act, to wit:
24	ORS 677.190(1)(a) unprofessional or dishonorable conduct, as defined in ORS 677.188(4)(a)
25	any conduct or practice contrary to recognized standards of ethics of the medical profession;
26	ORS 677.190(23) violation of the federal Controlled Substances Act; and ORS 677.190(24)
27	prescribing controlled substances without a legitimate medical purpose, or prescribing controlled

1	substances without following accepted procedures for examination of patients, or prescribing
2	controlled substances without following accepted procedures for record keeping. Licensee
3	understands that this Order is a public record and is a disciplinary action that is reportable to the
4	National Practitioner Data Bank and the Federation of State Medical Boards.

6	Licensee and the Board agree that the Board will close this investigation and resolve this
7	matter by entry of this Stipulated Order, subject to the following conditions:
8	4.1 Licensee surrenders his Oregon medical license while under investigation.
9	4.2 Licensee must not reapply for a medical license in the State of Oregon for at least
0	two years from the effective date of this Order.
11	4.3 Licensee must obey all federal and Oregon state laws and regulations pertaining
12	to the practice of medicine.
13	4.4 Licensee stipulates and agrees that any violation of the terms of this Order shall
14	be grounds for further disciplinary action under ORS 677.190(17).
