14.	initiating an investigation. In order to address the Board's concerns while this matter is under
5	investigation, Licensee and the Board agree to the entry of this Interim Stipulated Order, which
16	is not an admission of any wrongdoing on the part of the Licensee. Licensee understands the
17	terms of this Order and signs freely, without fraud or duress.

19	While this matter is under investigation, Licensee agrees to the following conditions:
20	3.1 Licensee voluntarily withdraws from the practice of medicine and her license is
21	placed in Inactive status pending the completion of the Board's investigation into her ability to
22	safely and competently practice medicine.
23	3.2 Licensee understands that violating any term of this Order will be grounds for
24	disciplinary action under ORS 677.190(17).
25	4.
26	At the conclusion of the Board's investigation, Licensee's status will be reviewed in an
27	expeditious manner. Following that review, if the Board determines that Licensee shall not be

1	permitted to return to the practice of medicine, Licensee may request a hearing to contest that
2	decision.
3	5.
4	This Order is issued by the Board pursuant to ORS 677.265(1) and (2) for the purpose
5	of protecting the public, and making a complete investigation in order to fully inform itself with
6	respect to the performance or conduct of the Licensee and Licensee's ability to safely and
7	competently practice medicine. Pursuant to ORS 677.425, Board investigative materials are
8	confidential and shall not be subject to public disclosure. However, as a stipulation this Order is
9	a public document and is reportable to the National Practitioner Data Bank and the Federation of
10	State Medical Boards. This Order becomes effective the date it is signed by the Board's
11	Executive Director or Medical Director in accordance with OAR 847-001-0030.
