

NOTICE OF WITHDRAWAL OF PETITION FOR IMMEDIATE TEMPORARY SUSPENSION

NOW COMES the Commonwealth of Pennsylvania, by and through its prosecuting attorney, David K. Grubb, to file this Notice of Withdrawal of the Petition for Immediate Temporary Suspension in this matter pursuant to 1 Pa. Code §35.51, and in support thereof, avers as follows:

- 1. On or about January 30, 2011, the Commonwealth forwarded a Petition for Immediate Temporary Suspension to the State Board of Medicine Probable Cause Screening Committee (Committee), which alleges that Respondent's continued practice of medicine makes Respondent an immediate and clear danger to the public health and safety.
- 2. On or about January 30, 2011, the Committee approved an Order of Temporary Suspension and Notice of Hearing, which was filed with the Department of State Prothonotary.
- 3. The Commonwealth and the Respondent have arrived at the terms of a Consent Agreement that would allow the Respondent to resume practice with appropriate safeguards and conditions.
 - 4. Upon further consideration of this matter, the Commonwealth has decided to

withdraw its Petition for Immediate Temporary Suspension at this time.

WHEREFORE, for the foregoing reasons, the Commonwealth respectfully provides notice of its withdrawal of the Petition for Immediate Temporary Suspension, pursuant to the General Rules of Administrative Practice and Procedure, 1 Pa. Code §31.1 et seq., at §35.51.
