ORDER OF TEMPORARY SUSPENSION AND NOTICE OF HEARING

AND NOW, this 22nd day of March, 2024, upon review of the Petition for Temporary Suspension of the license to practice as a graduate osteopathic trainee held by Tarik Y. Zeid, D.O. (*hereinafter* "Respondent"), license number OT019998, filed by the Prosecuting Attorney for the Commonwealth of Pennsylvania, the State Board of Osteopathic Medicine (*hereinafter* "Board") makes the following findings and enters the following Order:

SUSPENSION ORDER

The Board finds the Prosecuting Attorney has alleged facts in the Petition, which, if taken as true, establish at each and every count that the Respondent's continued practice as a graduate osteopathic trainee within the Commonwealth of Pennsylvania, along with the exercise of any other licenses, registrations, certificates, approvals, authorizations, or permits (*hereinafter referred to collectively as* "authorizations to practice the profession") issued by the Board, makes Respondent an immediate and clear danger to the public health and safety. Therefore, in accordance with Section 14(a) of the Osteopathic Medical Practice Act, act of October 5, 1978, P.L. 1109, No. 261, ("Act") as amended, 63 P.S. § 271.14(a), the Board **ORDERS** that the license to practice as a graduate osteopathic trainee issued to the Respondent, license number OT019998, along with any other authorizations to practice the profession issued by the Board to Respondent,

are **TEMPORARILY SUSPENDED** upon the service of this Order. Respondent shall surrender his wall certificate(s), biennial renewal certificate(s) and wallet card(s) (or notarized affidavit of their loss or destruction) to representatives of the Bureau of Enforcement and Investigation or the Bureau of Professional and Occupational Affairs, immediately upon service of this Order in accordance with Section 14(a) of the Act, 63 P.S. § 271.14(a).

PRELIMINARY HEARING

A preliminary hearing shall be scheduled and conducted by the Board or Office of Hearing Examiners to be convened within thirty (30) days from the date of issuance of this Order. The preliminary hearing shall be limited to evidence on the issue of whether there is a *prima facie* case to support the temporary suspension of the Respondent's license and other authorizations to practice the profession issued by the Board. The preliminary hearing will be held at a location designated by the Board or a hearing examiner for the Board.

The Respondent is entitled to be present at the preliminary hearing and may be represented by an attorney, cross-examine witnesses, inspect physical evidence, call witnesses, offer evidence and testimony and make a record of the proceedings.

If the Board or hearing examiner finds a *prima facie* case is not established, Respondent's license and other authorizations to practice the profession issued by the Board will be immediately restored. If a *prima facie* case is established, the temporary suspension shall remain in effect until vacated by the Board, but in no event longer than 180 days, unless otherwise ordered or agreed to by the participants.

ADDITIONAL FORMAL ACTION

In addition to this temporary suspension proceeding, the prosecuting attorney will commence a separate action to suspend, revoke or otherwise restrict Respondent's license and

other authorizations to practice the profession issued by the Board through the filing of a charging document, an Order to Show Cause. The Order to Show Cause may include, but not be limited to, the facts which were alleged in the Petition for Immediate Temporary Suspension. Any Order to Show Cause filed by the prosecuting attorney will be served upon the Respondent and the Order will direct Respondent to reply to the charges in a written answer within twenty (20) days of the issuance of the Order to Show Cause. A formal hearing on that Order to Show Cause will then be scheduled and conducted by the Board or the Hearing Examiner for the Board.

PROCEDURES

Continuances will be granted for good cause only. A request for a continuance must be filed with the Prothonotary, in writing, at least one (1) week prior to the date of the hearing. The requirement of the one (1) week advance filing of a request for continuance will be waived only upon a showing of good cause. The failure to have an attorney present and a request for continuance to retain an attorney will not be considered a valid reason for the granting of a continuance on the day of the hearing. **A request by the Respondent for an extension of time or a continuance which will delay the preliminary hearing or the formal hearing must be accompanied by the agreement of the Respondent that the 180-day temporary suspension will continue, but not begin tolling, during whatever additional time is necessary to conclude the proceedings.**

All proceedings are conducted in accordance with the Administrative Agency Law, 2 Pa.C.S. §§ 501-508, 701-704; 63 P.S. §§ 2201-2207; and the General Rules of Administrative Practice and Procedure, 1 Pa. Code §§ 31.1-35.251. A record of the hearing will be

stenographically prepared by an official reporting service. A copy of the transcript may be secured by personally making arrangements with the reporting service at the time of the hearing.



PETITION FOR IMMEDIATE TEMPORARY SUSPENSION

AND NOW, the Commonwealth of Pennsylvania, Bureau of Professional and Occupational Affairs, by and through its Prosecuting Attorney, Patrick M. Greene, petitions the State Board of Osteopathic Medicine (*hereinafter* “Board”) for the immediate temporary suspension of the license to practice as a graduate osteopathic trainee issued to **Tarik Y. Zeid, D.O.** (*hereinafter* “Respondent”), along with any other licenses, registrations, certificates, approvals, authorizations, or permits (*hereinafter referred to collectively as* “authorizations to practice the profession”) issued by the Board to Respondent at the time this Petition is Granted, pursuant to Section 14(a) of the Osteopathic Medical Practice Act, act of October 5, 1978, P.L. 1109, No. 261, (“Act”) as amended, (*hereinafter* “Act”), 63 P.S. § 271.14(a), and in support thereof alleges as follows:

1. Petitioner is a Prosecuting Attorney for the Bureau of Professional and Occupational Affairs, a departmental administrative agency within the Pennsylvania Department of State.
2. Respondent holds the following license to practice as a graduate osteopathic trainee in the Commonwealth of Pennsylvania: license no. OT019998.

3. Respondent's license was originally issued on May 1, 2020, is current through June 30, 2024 and, absent further Board action, may be renewed, reactivated or reinstated thereafter upon the filing of appropriate documentation and payment of the necessary fees.

4. At all times pertinent to the Factual Allegations, Respondent held a license to practice as a graduate osteopathic trainee in the Commonwealth of Pennsylvania.

5. Respondent's last known address on file with the Board is: 1338 Chestnut Street, Apt. #1612, Philadelphia, PA 19107.

COUNT ONE

6. Paragraphs 1 through 5 are incorporated by reference.

7. On or about December 19, 2023, the Central Detective Division of the Philadelphia Police Department filed an Affidavit of Probable Cause and a Criminal Complaint in the matter of Commonwealth of Pennsylvania v. Tarik Zeid at Docket No. MC-51-CR-0022458-2023 in the Municipal Court of Philadelphia County, charging Respondent with:

one (1) count of violating 18 Pa.C.S. § 3125(a)(1), Aggravated Indecent Assault, a Felony of the Second Degree;

one (1) count of violating 18 Pa.C.S. § 2718(a)(1), Strangulation, a Felony of the Second Degree;

one (1) count of violating 18 Pa.C.S. § 2902(a)(1), Unlawful Restraint, a Misdemeanor of the First Degree;

one (1) count of violating 18 Pa.C.S. § 907(a), Possession of Instrument of Crime, a Misdemeanor of the First Degree;

one (1) count of violating 18 Pa.C.S. § 3126(a)(2), Indecent Assault - Forcible Compulsion, a Misdemeanor of the First Degree;

one (1) count of violating 18 Pa.C.S. § 2706(a)(1), Terroristic Threats with Intent to Terrorize Another, a Misdemeanor of the First Degree;

one (1) count of violating 18 Pa.C.S. § 2701(a), Simple Assault, a Misdemeanor of the Second Degree;

one (1) count of violating 18 Pa.C.S. § 2705, Recklessly Endangering Another Person, a Misdemeanor of the Second Degree;

and one (1) count of violating 18 Pa.C.S. § 2903(a), False Imprisonment, a Misdemeanor of Second Degree.

8. True and correct copies of the Criminal Complaint and Affidavit of Probable Cause referenced in paragraph 7 are attached as **Exhibit A** and are incorporated by reference.

9. According to the December 19, 2023 Affidavit of Probable Cause:

a. On December 11, 2023 officers from the Sixth District referred to the Central Detectives the report of a domestic incident that happened on December 5, 2023 at 8:30 pm in an apartment on the 16th floor at the property on the 1300 block of Chestnut Street in the City of Philadelphia.

b. On December 12, 2023, the affiant interviewed the Complainant, J.B. about the domestic incident.

c. J.B. stated that on December 5, 2023 at 8:30 pm she was at Respondent's apartment. She stated that she had known Respondent for about a month. While at the apartment, they had conversations and had sex.¹

¹ Due to the nature of the allegations and in order to protect her privacy, J.B. is being identified only by her initials in this document. Respondent is aware of J.B.'s identity or should be aware of J.B.'s identity by way of the affidavit of probable cause and the fact that a preliminary hearing was held in the Municipal Court of Philadelphia County.

d. Respondent asked J.B. if she wanted to watch a movie and spend the night, but J.B. said that she had to leave because she had class in the morning and had to take care of her dogs. They started watching a movie at 10:30.

e. As they watched the movie, Respondent told J.B. that he used to hurt people really bad in his previous job and that he missed his job of hurting people. Respondent told J.B. that he could not tell people this because his medical license would get revoked. Respondent told J.B. that he got out of his previous job by killing someone just like her, and he said that he preferred killing people with a sniper rifle.

f. J.B. stated that Respondent told her that he loved her. J.B. responded by stating that it was too much and that she wanted to leave.

g. Respondent then wrapped his arm around her while they were both still on the bed, and she managed to shake his hands off her. Respondent then grabbed J.B. by the throat and pushed her down onto the bed. Respondent then put his other hand on the side of her face, pressed his face against her face, and stated "I killed 7 people like this."

h. J.B. stated that she repeatedly told Respondent that it was too much and to please let her go, but Respondent continued to hold her down by the throat. At some point he let her go, but he pinned her down by the throat 3 more times. J.B. reported she could not breathe from Respondent choking her.

i. Respondent asked her for sex but she denied repeatedly and she was able to convince him to let her go.

j. Respondent threw a heavy metal water bottle at her but did not hit her with the bottle.

k. J.B. stated that she grabbed her cell phone, and Respondent blocked the hallway door and began sobbing. J.B. told Respondent that she was worried about him and that this was not him.

l. Respondent convinced J.B. to get back into the bed and hold him. Respondent told her that he would let her leave if she would let him put his fingers in her vagina. J.B. stated that Respondent penetrated her vagina with his fingers for 10-15 seconds.

10. On or about January 31, 2024, a preliminary hearing in the matter of Commonwealth of Pennsylvania v. Tarik Zeid at Docket No. MC-51-CR-0022458-2023 was held in the Municipal Court of Philadelphia County, and the charges were held for court at Docket No. CP-51-CR-0000701-2024.

11. A true and correct copy of the criminal dockets referenced in paragraph 10 are attached as **Exhibit B** and incorporated by reference.

12. The criminal count of 18 Pa.C.S. § 3125(a)(1), Aggravated Indecent Assault, that Respondent has been charged with is defined as a “sexual offense” by Section 3113(i) of Act 53, 63 Pa.C.S. § 3113(i).

13. Pursuant to Section 3113(d), 63 Pa.C.S. § 3113(d), if Respondent is convicted of this sexual offense, the Board may not permit him to be licensed as graduate osteopathic trainee.

14. Based upon the foregoing factual allegations, the Respondent’s continued practice as a graduate osteopathic trainee in the Commonwealth of Pennsylvania, along with the exercise of any

other authorizations to practice the profession issued by the Board, makes Respondent an immediate and clear danger to the public health and safety.

WHEREFORE, the Petitioner respectfully requests that the Board issue an Order immediately suspending all of Respondent's authorizations to practice the profession issued by the Board, and in particular, the license to practice as a graduate osteopathic trainee, license number OT019998, pursuant to the authority granted to it pursuant to Section 14(a) of the Osteopathic Medical Practice Act, act of October 5, 1978, P.L. 1109, No. 261, 63 P.S. § 271.14(a).

On 12-12-23 complainant J.B was interviewed by Your Affiant at Central Detectives at 8:57 pm. Complainant J.B stated that on 12-5-23 at 8:30 pm she was at Tarik Zeid 32 yr. old W/M apartment which is on the 1300 block of Chestnut Street on the 16th floor. She states she has known Tarik Zeid for about a month. While at the apartment they had conversations and had sex. Tarik then asked J.B if she wanted to watch a movie and spend the night, J.B states she told him that was not possible, she had her dogs at home and had class in the morning. Tarik then asked her to put on the movie about 10:30 pm began to watch a movie.

As they were watching the movie Tarik began to tell J.B that his previous job he used to hurt people really bad and he missed his job of hurting people. Tarik further stated that he could not tell anyone else because his medical license would be revoked. Tarik then said that he got out of that job by killing someone just like me. He then said that he was really good at it and he preferred doing it (killing people) with a sniper rifle.

J.B states that Tarik then told her that he love her. J.B then told Tarik that this is too much, he needed to stop and I want to leave. Tarik then wrapped his arm around J.B. J.B states that she manage to shake his hands off of her. At the time they were both on the bed. Tarik then grabbed J.B by the throat, pushed J.B down onto the bed. Tarik then put his other hand on the side of her face, pressed his face against her face and stated "I KILLED 7 PEOPLE LIKE THIS" J.B states that she repeatedly told Tarik this is too much, please let me go. Tarik continued to pin her down by holding her throat. At some point he let go of her throat. He then pinned her down by the throat 3 more times. J.B stats that Tarik asked her for sex but she which she denied repeatedly. J.B states she was able to convince Tarik to her go. Tarik then threw a heavy metal water bottle at her but didn't hit her.

J.B states at that point she grabbed her cell phone. Tarik then blocked the hallway door and began sobbing. J.B then told Tarik that she was worried about him, this is not you. Tarik then convince J.B to get back in the bed and to hold him. Tarik then told her that he would let her go if she would let him finger her (put his finger(s) in her vagina) he would let her leave. J.B states that Tarik penetrated her vagina for 10-15 seconds.

J.B states that she could not breathe from Tarik choking her. J.B was she did not see any mark on her neck when she looked the following day.

J.B was shown a single photograph of Tarik Zeid which she provided and positively confirm that the same person she mentioned in her statement by signing and dating it.

AT OR NEAR THE 1300 BLOCK OF CHESTNUT ST THE DEFENDANT UNLAWFULLY RESTRAINED THE COMPLAINANT, J.B., BY REFUSING TO ALLOW HER TO LEAVE HIS APARTMENT AND PINNING HER DOWN BY HER NECK, SO AS TO, INTENTIONALLY OR KNOWINGLY IMPEDE HER BREATHING BY APPLYING PRESSURE TO HER THROAT.
