STIPULATION
AND
AGREEMENT

IN RE: DR. PAUL D. FRAZER

IT IS AGREED by the South Dakota Board of Medical and Osteopathic Examiners (the Board) and Dr. Paul D. Frazer (Dr. Frazer) as follows:

1. Dr. Frazer submitted an application for reinstatement and renewal of his medical license.
2. Dr. Frazer agreed to and participated in an evaluation at Acumen Assessments in Lawrence, KS, and he authorized Acumen Assessments to provide and evaluation report to the Board.
3. Informal Agreement: It is the intent of the parties hereto to provide for the informal compromise and settlement of all issues which could be raised by a formal contested hearing.
4. Waiver of Rights: Dr. Frazer understands he has the right to consult with an attorney of his own choosing who is licensed in South Dakota. If no attorney is present or signs this agreement, he understands that he has waived said right. He also understands that he has a right to contest this Stipulation and Agreement in an administrative hearing before an impartial administrative judge. Dr. Frazer understands and agrees that by signing this Stipulation and Agreement, he is waiving his rights to a hearing, and he is voluntarily and knowingly giving up his right to present oral and documentary evidence, to present rebuttal evidence, to cross-examine witnesses against him, and to appeal the Board's decision to Circuit Court.

The Board and Dr. Frazer agree that if his medical license is reinstated and renewed, the following conditions shall apply:

Dr. Frazer shall comply with all the recommendations included in the October 22, 2010 Report from Acumen Assessments

Dr. Frazer shall authorize Acumen Assessments to immediately notify the Board in the event difficulties or concerns arise.

Dr. Frazer shall authorize Acumen Assessments to provide reports to the Board regarding all future evaluations, meetings, or other activities at Acumen Assessments.

Dr. Frazer understands and agrees that this Stipulation and Agreement shall be presented to the Board where it shall be approved, rejected or modified.

Dr. Frazer understands and agrees that requests to amend this Stipulation and Agreement are at the discretion of the Board. Any request to amend this

agreement shall be submitted to the Board in writing. Dr. Frazer further understands and agrees that should the Board approve any amendments or changes to this agreement, they are not valid until he is notified in writing.

Dr. Frazer understands and agrees that any violation of this Stipulation and Agreement constitutes unprofessional conduct under the Medical Practices Act.

Dr. Frazer understands and agrees that this Stipulation and Agreement is a public record of the Board and the State of South Dakota. As such, it shall be published on the Board's website and reported as deemed necessary by the Board in compliance with state and federal law and if necessary including but not limited to the National Practitioner Data Bank.

Dr. Frazer has unconditionally agreed to this Stipulation and Agreement by affixing his signature to this document.

NOW; THEREFORE, the Board hereby:


APPROVES AND ACCEPTS the Stipulation and Agreement and the Temporary Order; and
