Dear Dr. Arboleda:

This letter is official notification of the decision of the informal conference committee of the Virginia Board of Medicine which met with you on December 6, 1991 in Williamsburg, Virginia.

Upon thorough review of the matters before it, the Committee found that you have violated Section 54.1-2915.A(4) and (3) as further defined in Section 54.1-2914.A(3), (9), (10), Section 54.1-3303 and Section 54.1-3408 of the Code, in that:

From on or about September 29, 1986 to March 6, 1991, you excessively and indiscriminately prescribed to Patient A, a person you knew to be chemically dependent, various controlled substances of high abuse potential, to wit: 3625 dosage units of Centrax (prazepam) 10 mg (Schedule IV), 790 dosage units of oxycodone with acetaminophen (Schedule II), 5680 ml. of Tussionex Suspension (Schedule III), 300 dosage units of acetaminophen with codeine (Schedule III), 40 dosage units of Xanax 1 mg (Schedule IV), 32 dosage units of Librium 25 mg (Schedule IV), and 30 dosage units of codeine sulfate 15 mg (Schedule III).

The Committee voted to recommend that no sanction be imposed against your license to practice medicine in the Commonwealth of Virginia. The Committee's decision in this matter will become a permanent part of the public record of the Board of Medicine. Pursuant to Section 9-6.14:12 of the Code, you have the right to appeal the findings of the informal conference committee. Should you reject the Committee's decision you must, within thirty (30) days of receipt of this letter, request a formal administrative hearing in this matter. Relevant Sections of the Code have been enclosed for your reference.
