**CLOSED SESSION:** 

Upon a motion by Ms. Hickey, and duly seconded by Dr. Zahir, the Committee voted to convene a closed meeting pursuant to §2.2-3711.A (27) of the Code of Virginia, for the purpose of deliberation to reach a decision in the matter of Dr. Newman. Additionally, she moved that Ms. Deschenes and Ms. Wood attend the closed meeting because their presence in the closed meeting was deemed necessary and would aid the Committee

in its deliberations.

**RECONVENE:** 

Having certified that the matters discussed in the preceding closed session met the requirements of §2.2-3712 of the Code, the Committee re-convened in open session and announced its

decision.

**DECISION:** 

Upon a motion by Ms. Hickey, and duly seconded by Dr. Zahir, the Committee made certain findings of fact and conclusions of law and voted to issue Dr. Newman a reprimand and place his

license on terms and conditions.

**VOTE:** 

The vote was unanimous.

ADJOURNMENT:

The Committee adjourned at 4:06 p.m.

As provided by law this decision shall become a Final Order thirty (30) days after service of such Order on Dr. Newman, unless a written request to the Board for a formal hearing on the allegations made against him is received from Dr. Newman, within such time. If service of the Order is made by mail three (3) additional days shall be added to that period. Upon such timely request for a formal hearing, the decision of the Special Conference Committee shall be vacated.

**ORDER** 

JURISDICTION AND PROCEDURAL HISTORY

Pursuant to Virginia Code §§ 2.2-4019 and 54.1-2400(10), a Special Conference Committee of

the Virginia Board of Medicine ("Board") held an informal conference on September 22, 2021, in

Henrico County, Virginia, to inquire into evidence that Ira Clifford Newman, M.D., may have violated

certain laws and regulations governing the practice of medicine in the Commonwealth of Virginia.

Ira Clifford Newman, M.D., appeared at this proceeding and was represented by Nicholas A.

Balland, Esquire.

Upon consideration of the evidence, the Committee adopts the following Findings of Fact and

Conclusions of Law and issues the Order contained herein.

FINDINGS OF FACT AND CONCLUSIONS OF LAW

1. Ira Clifford Newman, M.D., was issued License Number 0101-057155 to practice

medicine on January 28, 1998, which is scheduled to expire on March 31, 2022. At all times relevant to

the findings contained herein, said license was current and active.

2. Dr. Newman violated Virginia Code § 54.1-2915(A)(12) and (18) and 18 VAC 85-20-

29(A)(2) of the Regulations Governing the Practice of Medicine, Osteopathy, Podiatry and Chiropractic

in that, between approximately November 2019 and January 2020, he engaged in an egregious pattern

of disruptive behavior and/or interaction of a lewd and offensive nature in a healthcare setting that

interfered with or could reasonably be expected to adversely impact the quality of care rendered to

patients. Specifically:

- a. During this period, Individual A's employer, an independent, psychiatric nurse practitioner, rented office space in a building owned by Dr. Newman, in which Dr. Newman practiced psychiatry. While in the office with Individual A:
- i. Dr. Newman informed Individual A that he had herpes, and made inappropriate, sexually explicit comments to Individual A. Individual A stated that, for example, Dr. Newman would enter the office(s) and tell Individual A that she was pretty, had a nice ass, and looked like she would be good in bed.
- ii. Individual A stated that she admonished that this was inappropriate work/office conduct and that she was married.
- b. Between December 2019 and January 2020, Dr. Newman's conduct escalated into unwanted physical, sexual contact with Individual A, as detailed below:
- i. In or about December 2019, Dr. Newman came up from behind Individual A, who was on the phone speaking to a patient, put his hand down her blouse, and grabbed Individual A's left breast. Individual A stated that she instructed Dr. Newman to stop. Individual A reported that Dr. Newman stated she should just take care of the phone call. Individual A stated that she had to pull Dr. Newman's hand out from her blouse. Individual A stated that after the incident, she left work for the day because she was upset.
- ii. On or about January 15, 2020, Individual A was in the staff break room when Dr. Newman entered the room, turned Individual A around, held her hands to the left side of her body, and "dry humped" her from behind, during which time Individual A reported that she requested, at least four times, that Dr. Newman stop. Eventually, after approximately several minutes, Dr. Newman stopped when he heard a nearby office door open. Individual A reported that when Dr. Newman let her go, she ran to collect her belongings and left the building.

- c. Subsequently, Individual A's employer stated that Dr. Newman apologized "profusely" to him for touching Individual A, stated he would also apologize to Individual A, and promised this employer that he would not engage in such conduct again. Thereafter, to avoid further contact with Dr. Newman, Individual A performed her work duties from home to the extent possible, until her employer moved his practice to another office location/physical address.
- 3. Dr. Newman admitted to the Committee that he put his hand down Individual A's blouse and grabbed her left breast while the individual was in the office reception area, stating that it was "brief."
- 4. When questioned by the Committee about the event detailed above in Paragraph 2(b)(ii), Dr. Newman denied that he held Individual A's hands to the side of her body, or that he forced himself on her. Dr. Newman further stated that Individual A and he had playfully engaged in other acts of consensual, mutual sexual touching for a period of time while in the office.
- 5. Dr. Newman stated that he was being "polite" when he offered to apologize/apologized to Individual A as described in Paragraph 2(c) above.
- 6. Dr. Newman admitted to the Committee that he made sexual comments to Individual A in the office, but stated that the comments were in the context of consensual banter between the two. Dr. Newman admitted that it was unprofessional to engage in consensual flirting at the office. He further stated to the Committee that the sexual interactions and touching incidents that Individual A and he engaged in were brief, consensual, and discrete, as no patients were present in the office when these interactions occurred.
- 7. Dr. Newman stated to the Committee that on one occasion, Individual A mistakenly sent her husband a flirtatious, sexual text message intended for Dr. Newman, which upset her. Dr. Newman stated that after this incident, Individual A's attitude toward him changed and she reported the conduct to her employer.

- 8. In January 2020, Individual A reported the conduct referenced herein to the Fairfax County Police Department. The Committee noted factual discrepancies between Dr. Newman's statements as documented in the responding officer's police report, statements made by Dr. Newman in his April 23, 2020 written statement to the Department of Health Professions' ("DHP") investigator, and what Dr. Newman reported while meeting with the Committee. The Committee noted additional factual discrepancies between Dr. Newman's statements and statements documented by the DHP investigator during her April 2020 interviews of Individual A and her employer.
- 9. The Committee noted that by Order entered September 20, 2021, the Circuit Court of Fairfax County, Criminal Division, dismissed two misdemeanor charges of sexual battery (Virginia Code § 18.2-67.4) brought against Dr. Newman, relative to Individual A's allegations of unwanted physical, sexual touching, as detailed above in Paragraph 2.
- 10. Dr. Newman stated to the Committee that as it is most important to him to practice in a safe manner and to help his patients, he is engaging in counseling to ensure that this conduct does not happen again.

#### **ORDER**

Based on the foregoing Findings of Fact and Conclusions of Law, the Virginia Board of Medicine hereby ORDERS as follows:

- 1. Ira Clifford Newman, M.D., is REPRIMANDED.
- 2. Dr. Newman's license is subject to the following TERMS AND CONDITIONS:
- a. Within 60 days from the entry of this Order, Dr. Newman shall ensure that his current therapist submits a report to the Board detailing his treatment dates, diagnosis(es), progress in therapy, and recommendations for ongoing treatment (including the recommended frequency of therapy visits).

b. Within six (6) months from the date of entry of this Order, Dr. Newman shall

provide written proof satisfactory to the Board of successful completion of a 15-hour Board-approved

Continuing Medical Education ("CME") course in the subject of professional ethics and boundaries. The

course shall be approved in advance of registration by the Executive Director of the Board. Requests

for approval must be received at least 15 business days prior to the course date. All continuing education

hours/courses shall be completed through face-to-face, interactive sessions (i.e., no home study, journal,

or Internet courses). Continuing education obtained through compliance with this term shall not be used

toward licensure renewal.

3. Any violation of the foregoing terms and conditions of this Order or any statute or

regulation governing the practice of medicine shall constitute grounds for further disciplinary action.

Pursuant to Virginia Code §§ 2.2-4023 and 54.1-2400.2, the signed original of this Order shall

remain in the custody of the Department of Health Professions as a public record, and shall be made

available for public inspection and copying upon request.

STATEMENT OF ALLEGATIONS

The Board alleges that:

1. At all times relevant hereto, Ira Clifford Newman, M.D. ("Respondent"), was licensed to

practice medicine and surgery in the Commonwealth of Virginia.

2. Respondent violated Virginia Code § 54.1-2915(A)(12), (13), (16) and (18) and 18 VAC

85-20-29(A)(2) of the Regulations Governing the Practice of Medicine, Osteopathy, Podiatry and

Chiropractic in that, from approximately November 2019 through January 2020, he engaged in an

egregious pattern of disruptive behavior and/or interaction of a lewd and offensive nature in a healthcare

setting that interfered with or could reasonably be expected to adversely impact the quality of care

rendered to patients. Specifically, during this period, Respondent, who owns and practices medicine

(psychiatry) in the building from whom Individual A's employer (a psychiatric nurse practitioner) rented

office space (for his independent practice), made inappropriate, sexually explicit comments to Individual

A while in the office(s). For example, Individual A stated that Respondent would enter the office(s) and

tell Individual A that she was pretty, had a nice ass, and looked like she would be good in bed. Individual

A also stated that despite admonishing Respondent that this was inappropriate work/office conduct and

that she was married, Respondent stated that he masturbated twice per day and had Herpes. Further,

between December 2019 and January 2020, Respondent's conduct escalated into unwanted physical,

sexual contact with Individual A, as detailed below:

a. In or about December 2019, Respondent came up from behind Individual A, who was on

the phone speaking to a patient, put his hand down her blouse, and grabbed Individual A's left breast.

Individual A stated that she instructed Respondent to stop. Individual A reported that Respondent stated

she should just take care of the phone call. Individual A stated that she had to pull Respondent's hand out

from her blouse. Individual A stated that after the incident, she left work for the day because she was

upset.

b. On or about January 15, 2020, Individual A was in the staff break room when

Respondent entered the room, turned Individual A around, held her hands to the left side of her body, and

"dry humped" her from behind, during which time Individual A reported that she requested, at least four

times, that Respondent stop. Eventually, after approximately several minutes, Respondent stopped when

he heard a nearby office door open. Individual A reported that when Respondent let her go, she ran to

collect her belongings and left the building.

c. Subsequently, Individual A's employer stated that Respondent apologized

"profusely" to him for touching Individual A, stated he would also apologize to Individual A, and

promised this employer that he would not engage in such conduct again. Thereafter, to avoid further

contact with Respondent, Individual A performed her work duties from home to the extent possible, until

her employer moved his practice to another office location/physical address.

d. On January 11, 2021, in the Fairfax County General District Court, Respondent was

found guilty of two misdemeanor counts of sexual battery, referenced below, and sentenced to twelve (12)

months confinement, with eleven (11) months suspended. Respondent is currently appealing this decision

in Fairfax Circuit Court.

3. Respondent violated Virginia Code § 54.1-2915(A)(16) in that he performed acts likely to

harm the public. Specifically, in or about December 2019 and on or about January 15, 2020, Respondent

engaged in nonconsensual sexual contact with Individual A, which resulted in his arrest and conviction

on two misdemeanor counts of Sexual battery (Virginia Code § 18.2-67.4). These charges were based

upon the unwanted physical, sexual touching of Individual A by Respondent in or about December 2019

and January 2020, as detailed above in Paragraph 2(a) and (b).
