CONSENT ORDER

JURISDICTION AND PROCEDURAL HISTORY

The Virginia Board of Medicine ("Board") and Ilan Anatole Kerman, M.D., as evidenced by their signatures hereto, in lieu of proceeding to an informal conference, enter into the following Consent Order affecting Dr. Kerman's license to practice medicine in the Commonwealth of Virginia.

FINDINGS OF FACT AND CONCLUSIONS OF LAW

- 1. Ilan Anatole Kerman, M.D., was issued License Number 0101-267333 to practice medicine on June 28, 2019, which is scheduled to expire on June 30, 2026.
- 2. Dr. Kerman violated Virginia Code § 54.1-2915(A)(4) and (14) in that he is unable to practice medicine with reasonable skill and safety due to illness, as evidenced by the following:
- a. On February 12, 2024, Dr. Kerman was arrested in Roanoke, Virginia and charged with indecent exposure outside a restaurant. During his transport by police officers to a magistrate, police bodycam and dashcam videos showed Dr. Kerman displayed erratic behavior by screaming, using racial slurs, and profanity interlaced with brief periods of calm.

- k. On May 16, 2024, the Board of Medicine received a letter from the U.S. Department of Veterans Affairs ("VA") alleging that Dr. Kerman had provided substandard care to nine patients on February 12, 2024, which was the same date of his manic episode and arrest for indecent

exposure. The alleged substandard care provided by Dr. Kerman purportedly caused significant harm to one patient by exacerbating the patient's symptoms of post-traumatic stress disorder. Another patient allegedly was vulnerable to adverse outcomes due to Dr. Kerman's failure to develop a comprehensive treatment plan to address the patient's mental health symptoms. For the remaining seven patients who were addressed in the letter, Dr. Kerman allegedly failed, among other things, to address medication refill requests resulting in one patient's visit to an emergency department. Due to these standard of practice complaints, the VA summarily suspended Dr. Kerman's privileges on February 15, 2024. The VA subsequently rescinded Dr. Kerman's suspension on December 23, 2024; however, under the terms of his return to employment, Dr. Kerman must have another psychiatrist present while treating patients.

- 1. Dr. Kerman's diagnosis of bipolar I disorder requires ongoing treatment and monitoring.
- 3. Pursuant to Virginia Code § 54.1-2400.2(K), the Board considered whether to disclose or not disclose Dr. Kerman's health records or health services.

CONSENT

- 1. I have been advised to seek advice of counsel prior to signing this document and I am represented by Nora T. Ciancio, Esq.;
- 2. I am fully aware that without my consent, no legal action can be taken against me or my license except pursuant to the Virginia Administrative Process Act, Virginia Code § 2.2-4000 et seq.;
- I acknowledge that I have the following rights, among others: the right to an informal factfinding conference before the Board; and the right to representation by counsel;
 - 4. I waive my right to an informal conference;

- 5. I neither admit nor deny the Findings of Fact and Conclusions of Law contained herein, but waive my right to contest such Findings of Fact and Conclusions of Law and any sanction imposed hereunder in any future judicial or administrative proceeding in which the Board is a party;
- 6. I consent to the entry of the following Order affecting my license to practice medicine in the Commonwealth of Virginia.

ORDER

Based on the foregoing Findings of Fact and Conclusions of Law, the Virginia Board of Medicine hereby ORDERS as follows:

- 1. Within thirty (30) days from entry of this Order, Dr. Kerman shall provide evidence satisfactory to the Board of entry into the Virginia Health Practitioners' Monitoring Program ("HPMP").
- 2. Dr. Kerman shall remain in the HPMP and comply fully with the terms of his contract(s), and any addenda thereto, until he successfully completes the program. In accordance with Dr. Kerman's contract, the Board will be notified of any non-compliance with, dismissal, or resignation from the HPMP.
- 3. Upon receipt of evidence of Dr. Kerman's participation in and successful completion of the terms specified by the HPMP, the Executive Director is authorized to close this matter, or refer it to a special conference committee for review.
- 4. Any violation of this Order or any statute or regulation governing the practice of medicine shall constitute grounds for further disciplinary action.

Pursuant to Virginia Code §§ 2.2-4023 and 54.1-2400.2, the signed original of this Order shall remain in the custody of the Department of Health Professions as a public record, and shall be made available for public inspection and copying upon request.
