**MODIFIED STIPULATION TO
INFORMAL DISPOSITION**

1. STIPULATION

The parties to the above-entitled matter stipulate as follows:

1.1 On December 21, 1998, the state of Washington issued Respondent a credential to practice as a physician and surgeon. Respondent's credential is currently active.

1.2 On August 17, 2017, the Medical Quality Assurance Commission (Commission) issued a Statement of Allegations alleging Respondent violated RCW 18.130.180(4).

1.3 On January 18, 2018, the Commission entered a Stipulation to Informal Disposition (January 18 Stipulation) In the Matter of Alexis Hallock, MD, (No. M2017-526).

1.4 On or about April 11, 2018, Respondent requested modification of the terms of the January 18 Stipulation.

1.5 A member of the Commission reviewed Respondent's request and proposed modification of the terms of the terms outlined below.

1.6 Respondent and the Commission agree to expedite the resolution of this matter by means of a Modified Stipulation to Informal Disposition.

1.7 Respondent waives the opportunity for a hearing on modification contingent upon the entry of this Modified Stipulation to Informal Disposition.

1.8 Respondent acknowledges that this Modified Stipulation to Informal Disposition is not binding unless and until it is accepted by the Commission.

1.9 If the Commission accepts this Modification Stipulation, it will be reported to the National Practitioner Data Bank (45 CFR Part 60), the Federation of State

Medical Boards' Physician Data Center and elsewhere as required by law. This Modified Stipulation is a public document. It will be placed on the Department of Health web site, disseminated via the Commission's electronic mailing list, and disseminated according to the Uniform Disciplinary Act (Chapter 18.130 RCW). It is subject to disclosure under the Public Records Act, Chapter 42.56 RCW, and shall remain part of Respondent's file according to the state's records retention law and cannot be expunged.

1.10 If the Commission rejects this Modified Stipulation to Informal Disposition, Respondent waives any objection to the participation at hearing of any Commission members who heard the Agreed Order on Modification presentation.

2. INFORMAL DISPOSITION

Pursuant to RCW 18.130.172(2) and based upon the above stipulation, the parties agree to the following Informal Disposition:

2.1 The Commission has jurisdiction over Respondent and the subject matter of this proceeding pursuant to chapter 18.130 RCW and the January 18 Stipulation.

2.2 **Surrender of License.** Respondent is retiring from the practice of medicine and voluntarily surrenders her license to practice as a physician and surgeon. This voluntary surrender is permanent and is effective on the effective date described below. Respondent agrees not to resume the practice of medicine in the state of Washington, including any temporary, emergency, or volunteer practice. Respondent has no right to reapply for licensure or to apply for license renewal, reinstatement or reactivation. Respondent must return all copies of her current license to the Commission within one week of the effective date of this Modified Stipulation.

2.3 **Effective Date.** The effective date of this Modified Stipulation is the date the Adjudicative Clerk Office places the signed Modified Stipulation into the U.S. mail. If required, Respondent shall not submit any fees or compliance documents until after the effective date of this Modified Stipulation.




The Commission accepts this Stipulation to Informal Disposition. All parties shall be bound by its terms and conditions.
